INTRODUCTORY SECTION

The National Internet Governance Forum has been held in the capital of the Republic of Moldova, Chisinau, since 2020. The annual National IGF has become a continuation of a global series of forums aimed at discussion of the most important issues of information society development, consolidation of the efforts of state authorities, business, Internet society, professional and academic elites aimed at accelerating the implementation of IT capabilities, creating conditions for comprehensive development of Internet technologies for the public benefit. MIGF gathers together participants from different countries who represent international organizations, state authorities, non-governmental and commercial organizations in the field of ICT and the mass media. Over the past few years, MIGF has become an important component of the national discussion on the future of the Internet in Moldova.

In 2024, the fourth Internet Governance Forum in Moldova, like the previous national forums, was held in a hybrid format. Taking into account trends at the global and regional level, the topic of building an open, free and secure digital future on a multi-stakeholder basis has become the main topic on this year's agenda. Discussions, in particular, revolved around key aspects of the development of digital infrastructure, regulation in the era of technological innovation, cybersecurity and digital sustainability, legislative and policy challenges for Internet freedom in Moldova.

The program of the two-day national event included plenary sessions and panel discussions with the participation of leading national and foreign speakers, and side events. Also, given the high interest from young people, the MIGF Youth Track was introduced for the first time as a platform for intergenerational dialogue, which will allow the voices of young people to be heard and taken into account in the development of appropriate resources and policies, and will also contribute to the formation of a culture of active youth participation. In addition, as part of the Open Microphone sessions, participants were able to make their comments and suggestions, as well as hold discussions with experts and speakers on issues of interest. The nature of the event presented new challenges and allowed to reach a wider audience – many experts and participants representing different stakeholder groups joined the fourth IGF in Moldova.

The Moldova Internet Governance Forum 2024 took place in Chisinau in the conference hall of the Student Hub. From 29 – 30 April, approximately 230 registered delegates from government institutions, civil society, private sector, industry, technical community, and academia met to discuss the most important issues for national Internet space. Some of them participated in the Forum from the conference hall, and some joined the online discussion. A number of well-known speakers and experts from Moldova, Romania, Ukraine, Canada, Germany, Belgium, Kazakhstan and several other countries took part in MIGF events.

The Moldova Internet Governance Forum 2024 was organized in accordance with the five core IGF principles, which are:

- Open and transparent
- Inclusive
- Bottom-up
- Multi-stakeholder
- Non-commercial

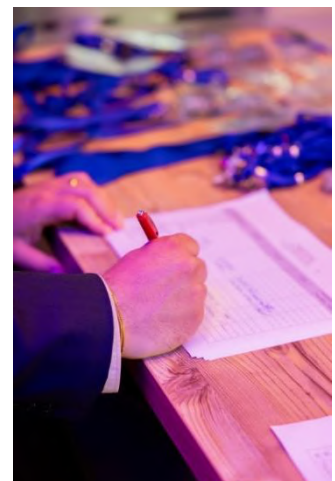
The Moldova IGF 2024 was organized by multi-stakeholder Organizing Committee representing national public and private sectors, civil society and technical community. The MIGF 2024 Program Committee included representatives from four stakeholder groups, as well as representatives from ICANN and RIPE NCC. The role of a neutral secretariat of the Internet Governance Forum in Moldova is entrusted to the

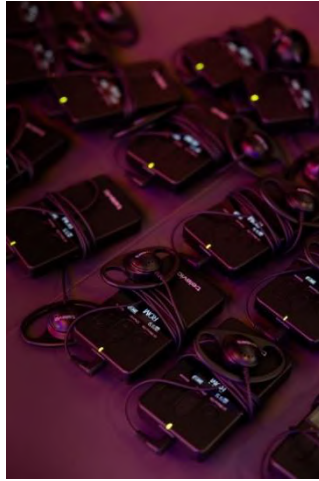
Association "Comunitatea Internet" - a non-governmental organization that supports and promotes the development of the open, secure, trustworthy, and unified global Internet. In this regard, it produces the reports and implements the decisions and report to the Organizing Committee that reviews and validates the implementation.

The Organizing Committee invited everyone who is interested in discussing current Internet governance issues to participate in the national initiative. Agenda was developed using a bottom up and multi-stakeholder approach. The Forum was supported by a number of government institutions, several international and regional organizations as well as local supporters and volunteers.

The Forum has become a space for discussions on Internet governance emerging issues, challenges and define the way forward. The Forum's formula has enabled a multilateral and open debate on the main challenges and opportunities presented by the development and popularization of the Internet. During the meeting, with the participation of the audience, the invited contributors were looking for new proposals and solutions, enabling a wise and responsible policy regarding the use and development of the Internet, responding to the emerging needs, including in the context of emergency situations and challenges to national and regional security.







WHAT IS THE INTERNET GOVERNANCE FORUM?

The Internet Governance Forum (IGF) is a global initiative under the auspices of the UN with the idea of bringing together all interested parties to participate equally in discussions and issues relevant to Internet governance. The initiative was created in 2006 at the "World Summit on the Information Society" (WSIS) in Tunisia, decided by the UN Secretary-General, as an open platform for discussion on Internet governance issues. The immediate motivation for this decision was the need to dissolve the governance and regulation of the Internet to the involvement of the wider community. It is important that other stakeholders such as civil society, academia, industry and the private sector take active part in these debates along the state representatives.

The IGF does not have a decision-making mandate, nor does it adopt binding acts, but their results may affect the procedure, which have binding effects. The IGF, by drawing its conclusions and drawing attention to topics that are relevant, can influence decision makers and thus participate in forming an official national position or public policy in the field of Internet governance.

The IGF is fully open to the participation of anyone interested in the issues of Internet stability, its security, usage and development. IGF is an annual event. Topics that will be discussed on the IGF can be suggested by anyone interested.

In addition to the [Global IGF](#) initiative, there are regional and sub-regional (e.g. [EuroDIG](#) – Pan-European Dialogue on Internet Governance, [SEEDIG](#) – South East European Dialogue on Internet Governance), national (e.g. Moldova IGF), age (Youth IGF).

IGF initiatives, especially national and regional ones, are important because they promote communication among all stakeholders, foster the development of a culture of dialogue among different stakeholders on Internet-related issues, which helps in anticipating different perspective and interests.

Important principles on which the IGF is based are:

- Openness and transparency (allowing all interested parties to participate in the IGF, public insight into all parts of the IGF's work);
- Inclusivity (enable active involvement of all concerned);
- Bottom-up approach (involving the public in the creation of the IGF program);
- Non-commercial - IGF is not intended for sale of goods and services;
- Multi-stakeholder model (model of involvement of all stakeholders: academia, business sector and industry, civil society organizations and state and public administration).

MOLDOVA IGF: KEY PRINCIPLES AND MAJOR POINTS

The idea of establishing a national platform for open dialogue on Internet Governance in Moldova emerged from inspiring and successful initiatives worldwide, such as the South Eastern European Dialogue on Internet Governance (SEEDIG), the Pan-European Dialogue on Internet Governance (EuroDIG), and a plethora of national initiatives that had sprung up all over the globe under the umbrella of the United Nations Internet Governance Forum.

Moldova Internet Governance Forum (MIGF) is a national IGF initiative for the Republic of Moldova dedicated to creating an open space for all stakeholders in order to develop an inclusive, diverse and informal dialogue on issues and problems concerning Internet governance. MIGF brings together representatives of various stakeholders to discuss global issues and topics from a national perspective, and finally to identify common priorities and make the first steps for a mutual cooperation.

Key Principles

Moldova Internet Governance Forum brings together individuals interested in national Internet Governance issues. Any interested person may join and participate in the Forum. Participation in the Internet Governance Forum is voluntary. It is organized in accordance with the main IGF principles: open and transparent, inclusive, bottom up, multi-stakeholder and non-commercial.

The main goals of MIGF are:

- to point out to various stakeholders the opportunities for involvement in Internet governance processes relevant to their business and activities, and to encourage dialogue and, if necessary, help in capacity building for better understanding Internet-related topics;
- to empower and interest all stakeholders in Moldova to actively participate in national, and then directly or indirectly, regional and international Internet governance processes;
- to identify Internet governance topics important to Moldova.

The main objectives of the Forum are:

- to provide an open and transparent platform for all stakeholder groups;
- to bring up and discuss the Internet governance related issues;
- to give the floor to the wide community;
- to deliver the messages to the policy makers.

The major directions of the Forum activity are:

- Protection of fundamental human rights and freedoms on Internet, support of democratic process and the rule of law;
- Support of implementation of the Internet governance with the participation of all stakeholders;
- Support of harmonization of international regulations and local legislation;
- Support of enhancing of Internet users' rights and capabilities;
- Promotion of the universalization of the Internet;
- Support of Internet security and reliability, sustainability and credibility;
- Support of formation of the decentralized approaches of the Internet governance based on social responsibility;
- Support of introduction of innovation, new technologies and services in the Internet sector;
- Introduction of the principles of open access and freedom of user's choice;
- Facilitation of the cultural and linguistic diversity in the Internet as well as support of development of local content increase.

The work of the MIGF is based on the recommendations and best practices of the United Nations Internet Governance Forum represented by the IGF Secretariat, the Council of Europe, the Internet Society (ISOC), the Internet Corporation for Assigned Names and Numbers (ICANN) and implies the multilateral engagement model of development of the Forum agenda, organization of the Forum with minimal costs and maximum transparency, and maximum involvement of the parties. The national Internet Governance Forum of Moldova is based on the cooperation of all stakeholders, bringing together 5 interested groups: government, private sector, civil society, the experts of scientific and educational and technology fields and the representatives of international organizations. All the participants are taking part in the Forum as equal partners.

MIGF 2024 PREPARATORY ACTIVITIES

The preparatory process for the fourth National IGF began in the fall of 2023 with stakeholder meetings. The organizing team has established a plan of activities to be performed before the planned event. Since then, the preparatory works of the Forum, meetings in the groups, forming of the agenda, and relationships with donors and supporters have started. Dialogue with youth organizations and structures representing marginalized communities was also intensified. As part of the preparatory activities, an updated version of the [MIGF website](#) was launched, which was brought into line with the current agenda.

Among the first steps, the activities on forming the new Organizing Committee have been initiated with the goal to connect the key stakeholders. The MIGF Organizing Committee included representatives from four stakeholder groups: government, technical community, private sector and civil society. The MIGF Program Committee included representatives from four stakeholder groups, as well as representatives from ICANN and RIPE NCC.

The role of a neutral secretariat of the Internet Governance Forum in Moldova is entrusted to the Association "Comunitatea Internet" - a non-governmental organization that supports and promotes the development of the open, secure, trustworthy, and unified global Internet. The Association is also in charge of the secretariat of the Organizing Committee. In this regard, it produces the reports and implements the decisions and report to the Committee that reviews and validates the implementation.

Members of the Organizing Committee, in particular, are responsible for:

- Select the central theme and sub-themes of the Forum;
- Draft the Forum TORs and the concept notes for sessions and themes;
- Seek and empower sessions and theme moderators;
- Seek additional support and funds to hold the Forum.

The topics for the event were selected from the proposals received in a bottom-up process following a public call for inputs. In accordance with the agreed session formats, up to six contributors were envisaged for each session. Moderators were encouraged to combine interventions from speakers with interactive discussions among all session participants.

On the eve of the event, over one hundred invitations were sent to representatives of all stakeholder groups. Moldova IGF 2024 was also announced on its website, on the website and/or social platforms of the UN IGF, SEE DIG, ICANN and RIPE NCC, on social media channels of national partners, specialized blogs and through the electronic and print media.

In planning the event, the Organizing Team sought to involve all stakeholder groups in the preparatory and organizational processes (government, academia, technical, private and civil society). Prominent

members of the local telecommunications and Internet sector have been invited to join the initiative accordingly.

As a target group, the Forum aimed to attract the local and regional Internet community, including market players, technical community and academia, supporting organizations, government officials, academics and young talents. A separate emphasis was placed on targeted activities aimed at involving underrepresented and marginalized groups.

The Organizing Committee regularly held coordination meetings from September 2023 to April 2024, especially in the preparatory phase, to discuss the strategy and make decisions with regards to calls for contributions, the list of speakers, the topics of agenda and partnerships. However, most communication took place in written form, via email, as quick feedback and reactions were needed to ensure deadlines were being followed. With regards to the Organizing Team, most of the preparatory meetings traditionally took place via Microsoft Teams or Zoom, as they had to happen more often. Regular meetings were needed in order to ensure that the calendar was being followed, that all stakeholder groups were consulted, and that all communication with speakers, participants and partners was being carried out in a timely, transparent and efficient manner. All in-person and online meetings have been documented through note taking and sharing of the meeting notes on the Organizing Team meetings.

Representatives of institutional and international partners of the Moldova IGF spoke at the opening of the event, as well as representatives of national partner organizations, key government institutions and the MIGF Organizing Committee. Some of the international speakers joined online, others came to Chisinau to participate in the discussion of the current IG agenda for Moldova, as well as related activities.

Anja Gengo, representative of the Global IGF Secretariat, National and Regional IGF Initiatives Coordinator, addressed the Forum participants with welcoming remarks during the live broadcast from the UN Headquarters in Geneva. The audience of the event was addressed by the international partners of Moldova Internet Governance Forum: **David Frautschy Heredia, Senior Director for European Government and Regulatory Affairs at Internet Society, Vahan Hovsepyan, Senior Community and Public Policy Advisor at the RIPE NCC, and Mikhail Anisimov, Head of Global Stakeholder Engagement for Eastern Europe and Central Asia at ICANN**. In their welcoming remarks, the representatives of international partner institutions welcomed the participants and contributors of the national Internet Governance Forum, drawing attention to the numerous challenges that Moldova currently faces in the online environment, and emphasizing the importance of the IGF platform as an open and inclusive space for dialogue between different groups of stakeholders, playing a unique role in the architecture of the digital cooperation.

Alexei Marciuc, National coordinator of the Internet Governance Forum in Moldova, Chairman of the Association "Comunitatea Internet", noted that taking into account trends at the global and regional level,

the theme of building an open, free and secure digital future on a multi-stakeholder basis has become the main topic on this year's agenda. "The overall objective of Moldova IGF 2024 is to promote inclusive, equal access to the Internet and digital technologies, increase cybersecurity and trust, support the growth of the digital economy and encourage digital innovation that meets the needs of the Republic of Moldova. Another important aspect is to contribute to the formation of a more flexible and balanced legal framework for the online environment," said Alexei Marciuc, Chairman of the Association "Comunitatea Internet".

The Chairman of the Parliamentary Committee on National Security, Defense and Public Order, Member of Parliament Lilian Carp welcomed the participants, noting that the Internet Governance Forum in Moldova is being held for the fourth time and has already become a tradition. He recalled reforms in the field of digitalization, as well as the creation of a new institution - the Agency for Cyber Security, which will deal with the prevention of cyber attacks and other threats in cyberspace. The Head of the Parliamentary Committee touched upon the topic of hybrid threats that Moldova faces in the context of military operations on the territory of Ukraine. "Cyber warfare has essentially become a new battlefield, and the Republic of Moldova has to face these new challenges," said the MP.

Lilian Carp called on civil society and other interested parties to more actively participate in the formation of control mechanisms for the intelligence services, whose powers in the online environment have recently been significantly expanded. "We are now holding a public debate about the creation of a permanent special commission that will ensure control over the Information and Security Service. Civil society is also participating in the discussion of this bill. We have presented this model, we are waiting for the vision of all institutions, as well as civil society, regarding this way of controlling this institution. Together we can find a balance," the Head of the Parliamentary Committee emphasized.

Director of the Information Technology and Cybersecurity Service (STISC), Alexandru Corețchi, noted the importance of multi-stakeholder discussions aimed at creating a safer and more inclusive online environment for everyone, as well as creating a culture of more responsible behavior in the virtual space. According to him, today society is not responsible enough to prevent and protect against cyber threats. "We are working to ensure the protection of our data in cyberspace, to ensure the protection of government services, their reliability and accessibility for the benefit of every citizen, so that he does not have many questions and concerns when using the Internet. But all users also need to be more responsible and check to distinguish trustworthy content from unreliable content," the STISC director emphasized.

Anatolie Golovco, Advisor to the Prime Minister on Cyber Security and Digital Transformation, suggested reflecting on the role of the state, how much and to what extent it can intervene, how it contributes to the development of the national segment of the Internet, in order to maintain a balance and not end up in an unpleasant situation when the government provides negative impact on the development of the Internet.

With reference to current data from the National Regulatory Agency for Electronic Communications and Information Technologies (ANRCETI), he noted that today in Moldova there are about 370 rural settlements where there is no Internet. "Even if these settlements have few inhabitants, they are still administrative units that obviously do not have the Internet for the simple reason that they are of no commercial interest. This is probably where the government should intervene. It is necessary to promote the development of the network and the growth of digital transformation in these regions," said Anatolie Golovco, Advisor to the Prime Minister.

Victoria Cociug, Doctor of economics, Vice-Rector for Research and Partnerships at the Academy of Economic Studies of Moldova (ASEM), one of the largest public universities in the country, noted the importance of involving the student community and the younger generation in general in the processes

of Internet governance at the national and international level, emphasizing the extremely important role of the Internet and information technologies in the formation of the modern information society. According to the Vice-Rector, the constant digital development brings new challenges both in the policy agenda and in the educational process, and the need for capacity building of scientific-teaching staff.

Representatives of key state institutions noted that Moldova Internet Governance Forum is a great opportunity to discuss the most important and topical issues related to the use and development of the digital environment, in the context of cooperation between different categories of stakeholders and with the participation of regional and international actors. The speakers also noted the rich and varied program of the event, wishing all participants and contributors productive work, interesting and constructive discussions during the two days of the Forum.





DAY 1 - Session 1

Digital infrastructure: realizing the potential of the Republic of Moldova in the era of technological advances

The discussion during this plenary session focused on the importance of digital infrastructure for sustainable development of the country and the region, the role of the Internet and digital technologies in improving access to information and services, and supporting the country's economic growth. National and international experts representing government institutions, private sector and international bodies discussed opportunities for strengthening cooperation on infrastructure development, as well as opportunities to engage international partners and investors to support infrastructure projects, stimulate innovation to create new solutions and approaches to sustainable infrastructure development. Experts and officials drew attention to the need to strengthen digitalization and use innovative approaches to ensure the sustainability of infrastructure projects and systems.

The session participants discussed how the effective development and modernization of digital infrastructure can help unlock the economic and social potential of the Republic of Moldova. The focus was on creating the reliable and accessible network infrastructure needed to support a wide range of

digital technologies and services. The presentations also addressed how innovations in telecommunications, Internet of Things, cloud computing and big data can be integrated into existing systems to improve their efficiency and reliability.

Particular attention was paid to the accessibility and inclusiveness of digital infrastructure so that the benefits of digitalization are available to all segments of the population, including marginalized communities and residents of small settlements in rural areas.



DAY 1 - Session 2

Shaping a safer digital future in the Republic of Moldova: new strategies, initiatives and cooperation in the face of growing cyber threats

With the increasing opportunities of digital transformation, new challenges are also emerging, including in the field of cybersecurity, data protection and ensuring the stable operation of digital systems. The session, which was joined by international and national experts representing Parliament, the Agency for Cyber Security, as well as Access Now and civil society organizations from Moldova, discussed various aspects of cybersecurity and digital resilience in the country and region, including strategies and initiatives, contributing to the creation of a secure and sustainable digital future for the Republic of Moldova on a multi-stakeholder basis.

The session featured examples of successful national and regional initiatives demonstrating effective methods for sharing knowledge, experience and resources to improve digital resilience.

In addition, the discussion touched upon the importance of digital hygiene programs for various categories of users and advanced training in the field of cybersecurity, which play a key role in increasing awareness of cyber threats and developing digital culture skills among the population and different types of organizations. The need to strengthen cooperation at various levels to counter growing cyber threats, strengthening partnerships between the institutions of the Republic of Moldova and relevant international actors was considered, which will allow the exchange of knowledge and experience, as well as receiving appropriate support and training in this area.

During the discussions, experts also paid attention to the need for the country to further adapt to new cyber threats and technological changes in the context of growing challenges in the online environment, as well as discuss innovative approaches and technologies that can help adapt to the changing technological landscape and ensure the safety of citizens, organizations and government agencies in the digital world.

At the third session of the Moldova IGF, international and national experts from various fields addressed key issues related to creating an effective regulatory environment to support and develop digital innovation, ensuring cybersecurity and equal access in the digital space. The discussion focused on the need to develop flexible regulatory frameworks that facilitate the integration of advanced technologies such as artificial intelligence, Internet of Things, big data and cloud computing into a country's economy and legal system.

Representatives from key government institutions, private information and communications technology companies, technical experts and civil society experts discussed how to create a regulatory environment that not only accelerates technological development, but also ensures the responsible and ethical use of

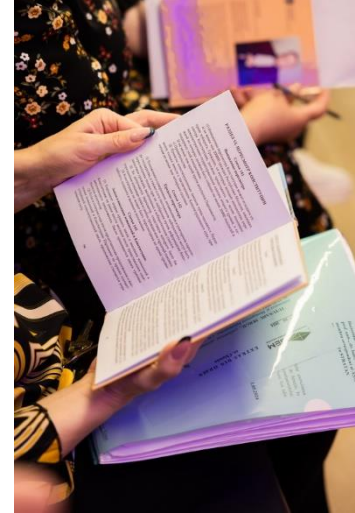
technology. During the session, contributors paid attention to the importance of adapting regulatory approaches to the rapidly changing technological landscape, and also discussed how regulation can stimulate innovation and technological breakthroughs, ensuring the protection of users and society, and equal access to digital achievements.

During the session, experts discussed the role of the state, business, academic and expert communities in creating a regulatory environment that promotes digital inclusion and sustainable development, and also presented diverse views and exchanged experience on effective regulatory practices in order to develop practical recommendations for improving the regulatory landscape.

The event also addressed a wide range of issues related to the introduction of AI into modern society and its impact on various aspects of our lives; the potential benefits and risks of artificial intelligence and other emerging technologies such as blockchain, big data analytics, cloud computing and quantum technologies. Topics included the ethical implications of artificial intelligence systems, the potential of digital technologies to enhance or reduce existing inequalities, and the need for international cooperation to ensure the responsible development and use of these technologies.

According to the panelists, the session contributed to the development of meaningful dialogue and exchange of views on how best to regulate and support digital transformation in the Republic of Moldova, taking into account the country's unique challenges and opportunities. As noted by the participants in the multi-stakeholder dialogue, it is necessary to develop and implement solutions that promote the responsible use of AI, protect data, preserve privacy and maintain public trust in new technologies.

The second day of MIGF 2024 opened with a side event with the participation of national and international contributors, dedicated to policy and legislative issues related to the regulation of the online environment, new challenges and ways to adapt to modern realities in the context of national and regional security risks. The event was attended by leading experts in the field of cybersecurity, media, freedom of expression online, personal data protection, and digital rights, as well as representatives of authorities and international institutions.

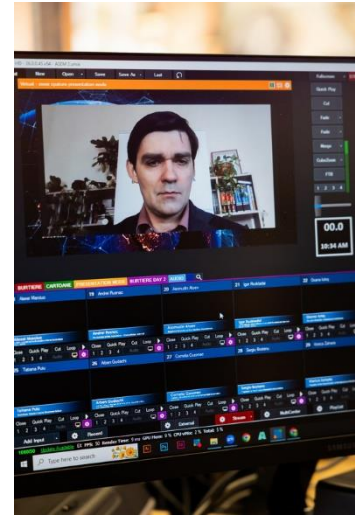
Participants of the multi-stakeholder side event discussed approaches to the formation of a legal framework regulating the online environment. In addition, the subject of discussion was the latest events

and trends affecting Internet freedom in the Republic of Moldova, including the policy of expanding the powers of law enforcement agencies. As evidenced by expert and statistical analysis of legislative activity, in Moldova there has recently been a rapid tendency towards excessive tightening of regulatory practices, and at the same time some draft laws do not contain clear criteria and grounds for interference with rights and freedoms, which creates preconditions for ambiguous interpretation and high risks of abuse.

The event discussed, in particular, the provisions of the National Security Strategy of the Republic of Moldova, approved by the Parliament on December 15, 2023, which covers a six-year period and contains a number of provisions that may have a significant impact on Internet freedom in Moldova. The Strategy envisages the harmonization of the national legal framework with the set security goals and objectives, taking into account the need to meet the preconditions for the country's accession to the European Union. National and international experts discussed approaches and [recommendations developed by the Association "Comunitatea Internet"](#), that will allow, when elaborating the forthcoming legislative changes related to the implementation of the National Security Strategy, to avoid possible abuses and ambiguous interpretation of legal provisions.

The discussions will contribute to the search for a balanced format of online regulation and the formation of progressive state policy in this area, taking into account expert recommendations, international experience and best practices. In the future, it is crucial for Moldova to create a favorable legal environment for the online space and develop its legislation, taking into account the need to maintain a balance between security issues and civil liberties.

Through sustained outreach and constant interaction between government institutions, the private sector, civil society and the technical community, with the support of international organizations, initiatives and foundations, a certain consensus has been reached in Moldova regarding the importance of Internet Freedom. However, in the context of national and regional security developments, there are increasing challenges that pose significant risks of negative consequences for online freedom, possible abuses and ambiguity in the application of regulatory frameworks, which prioritises the importance of

maintaining research and advocacy activities on policies and laws for preserving an open and free Internet and promoting fundamental freedoms in the virtual space.

In the second part of a special side event dedicated to Internet Freedom, well-known experts examined trends in the regulation of the online environment in Moldova, taking into account the extent to which the country complies with national and international standards related to freedom of expression, dissemination of information, balanced monitoring of online content and privacy protection. Contributors discussed approaches to developing and applying common principles, norms and decision-making procedures governing the online environment that are based on a broad, multi-stakeholder approach and take into account economic, political and sociocultural factors.

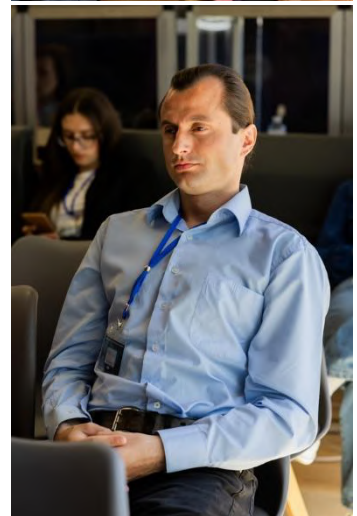
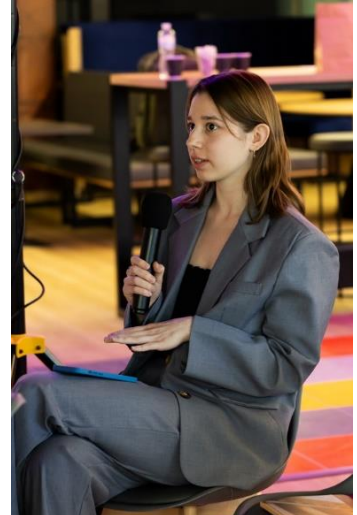
This side event was attended by representatives of different stakeholder groups - international actors, public sector, the academic community, civil society, and a youth initiative group.

This side event is designed to bring together young leaders, representatives of the student community and experienced stakeholders, fostering meaningful dialogue and collaboration between generations. By facilitating an open exchange of ideas, experiences, and expertise, the event seeks to chart a course towards a safer digital landscape for everyone. It highlights the crucial significance of implementing sound digital policies, laying the foundation for a secure and responsible digital future.

Young leaders and stakeholders were invited to actively participate in Internet governance processes, including the IGF, its intersessional work and annual meetings. The Youth IGF Initiative launch should facilitate the development of Internet governance skills and knowledge among the younger generation and ensure that their voices are heard and taken into account in the development of relevant resources and policies, as well as foster a culture of active youth participation. Participants of the event had the opportunity to learn about youth-related issues and key international actors in the Internet governance ecosystem, as well as discuss current issues in youth policy and the digital agenda.

At the Open Microphone session, representatives of the student community and the younger generation in general who took part in the side event had the opportunity to communicate directly with well-known national experts and representatives of relevant international organizations in order to receive answers to questions of interest to them.







DAY 2 - Closing session

Conclusions and Final Remarks



The IV National Internet Governance Forum ended its work with a closing session, at which representatives of government agencies, business, the scientific and technical community, civil society organizations, the student community and youth, as well as international and national partners of MIGF, representatives of the Organizing Committee had the opportunity to express their opinions and make comments and suggestions based on the results of the event.

The closing session speakers noted that the current Moldova Internet Governance Forum has become an effective multi-stakeholder platform for exchanging ideas, experiences and strategies, reviewing best practices and contributing to the overall digital development agenda, and the event provided a fruitful dialogue between various stakeholder groups, facilitating discussions of public policy issues regarding the Internet. At the same time, the session participants spoke in favor of capacity building and the development of Internet governance initiatives at the national level, including a youth track and programs to involve the younger generation in Internet governance processes at all levels.

As noted by representatives of the Organizing Committee, during two days, the event gathered about 40 representatives of key government institutions and leading experts from Moldova, Romania, Ukraine, Canada, Germany, Belgium, Kazakhstan and several other countries. Among them were representatives of key government agencies, technical and expert community, civil society, media, business, international and regional organizations. This year's MIGF agenda included discussion of key aspects of digital infrastructure development, regulation in the era of technological innovation, cybersecurity and digital sustainability, as well as legislative and policy challenges to Internet freedom in Moldova.

Representatives of Internet Corporation for Assigned Names and Numbers (ICANN), Réseaux IP Européens Network Coordination Centre (RIPE NCC) and SecDev Foundation, who took part in the closing of the event, noted that the fourth edition of MIGF turned out to be interesting, informationally rich, with a relevant and well-thought-out agenda, with a large number of participants from various stakeholder groups.

Mikhail Anisimov, Head of Global Stakeholder Engagement for Eastern Europe and Central Asia at ICANN, drew attention to the high level of representation of key national actors in the field of Internet governance and digital development, including the leadership of government agencies responsible for this segment. In particular, the MIGF discussions were attended by representatives of the Parliament, Government,

National Agency for Electronic Communications and Information Technology (ANRCETI), Information Technology and Cybersecurity Service (STISC), Agency for Cybersecurity.

Vahan Hovsepyan, Senior Community and Public Policy Advisor at the RIPE NCC, added that he has attended many similar events in different countries of the region, but Moldova is one of the few examples when the national IGF platform managed to organize such an open and honest dialogue between key government officials and representatives of other stakeholder groups to find solutions and discuss the most relevant topics of interest to the local IG-community.

Within the MIGF events, ICANN and RIPE NCC representatives held negotiations with the management of the National Agency for Electronic Communications and Information Technology (ANRCETI) and Information Technology and Cybersecurity Service (STISC), during which decisions were reached on measures aimed at strengthening the sustainability and security of the national segment of the Internet in the Republic of Moldova. Within the Information Technology and Cybersecurity Service, the DNS L ROOT mirror has been activated as of 01.05.2024,¹ in accordance with STISC responsibilities regarding the management of domain names in the Republic of Moldova. As a result of the STISC's association with ICANN, the services provided to the public and private sectors will benefit from greater credibility, security, performance and redundancy, while providing autonomy of national resources from the global Internet.

In addition, as a result of negotiations and consultations between representatives of the Government, RIPE NCC, ANRCETI and STISC, it was agreed to increase the use of RIPE Atlas, which is the RIPE NCC's main Internet data measurement system. This will allow public institutions to actively measure Internet connectivity in different regions of the country, including remote rural areas, in real time in order to improve the resilience of the Internet in Moldova.

Joining the closing session, Asomudin Atoev, Regional director of the SecDev Foundation, noted that the discussions and presentations during the current edition of MIGF brought out many ideas, opinions and innovative proposals that can be used to develop common approaches and solutions at the regional and global level. According to him, the Moldova Internet Governance Forum addressed the most topical issues of the national and international Internet agenda, including legal, political, social and technical ones.

In conclusion, the Organizing Committee thanked all international and national partners, the team of organizers and volunteers, as well as the speakers, moderators, contributors, and participants who joined the national initiative for contributing to a productive and successful event.

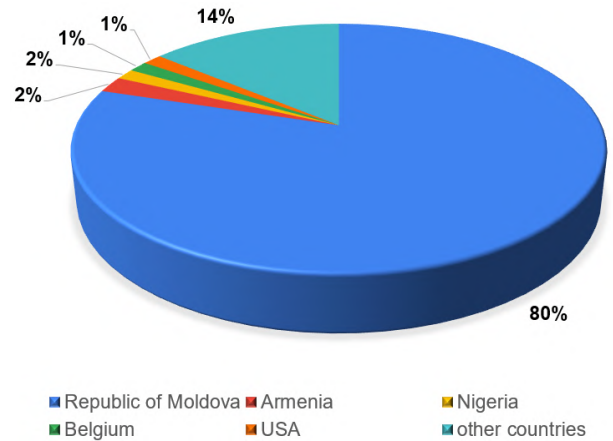

BREAKDOWN BY COUNTRY

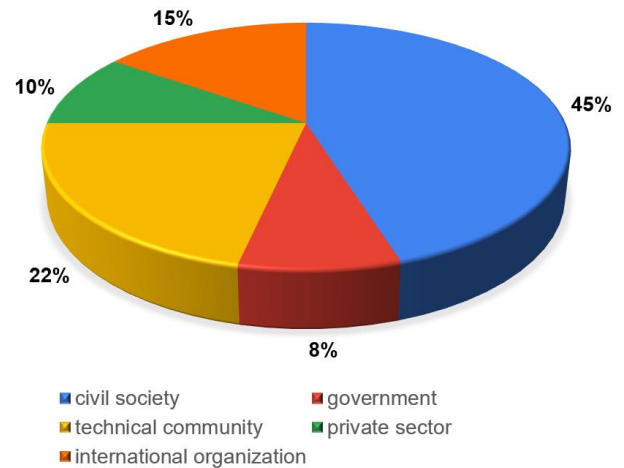

PARTICIPANTS OF THE FORUM ACCORDING TO THEIR AFFILIATION

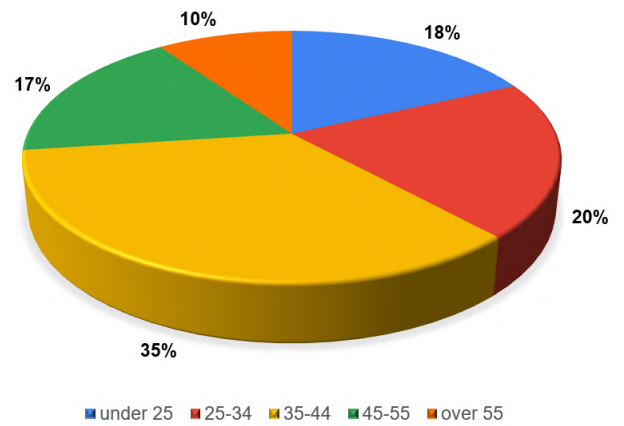

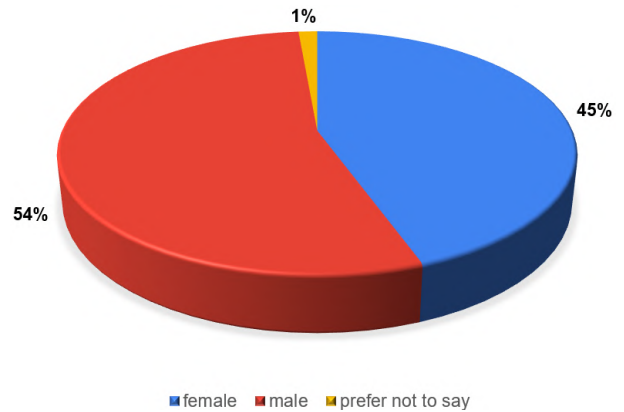
BREAKDOWN BY AGE

The most represented age group was the group of 35-44 years old, which made up about a third of all participants (35%). This year, representatives of the younger generation were also actively involved in the IS process: 18% of participants were under 25 years old and 20% aged 25-34 years. The least represented group was people 55 and older at 10% (however, this is up 1% from last year).

In regards to gender representation, men (54%) were prevalent at the Forum. The largest disproportion was recorded among the group of stakeholders representing government institutions, where women constituted only about one third of the group (33%).



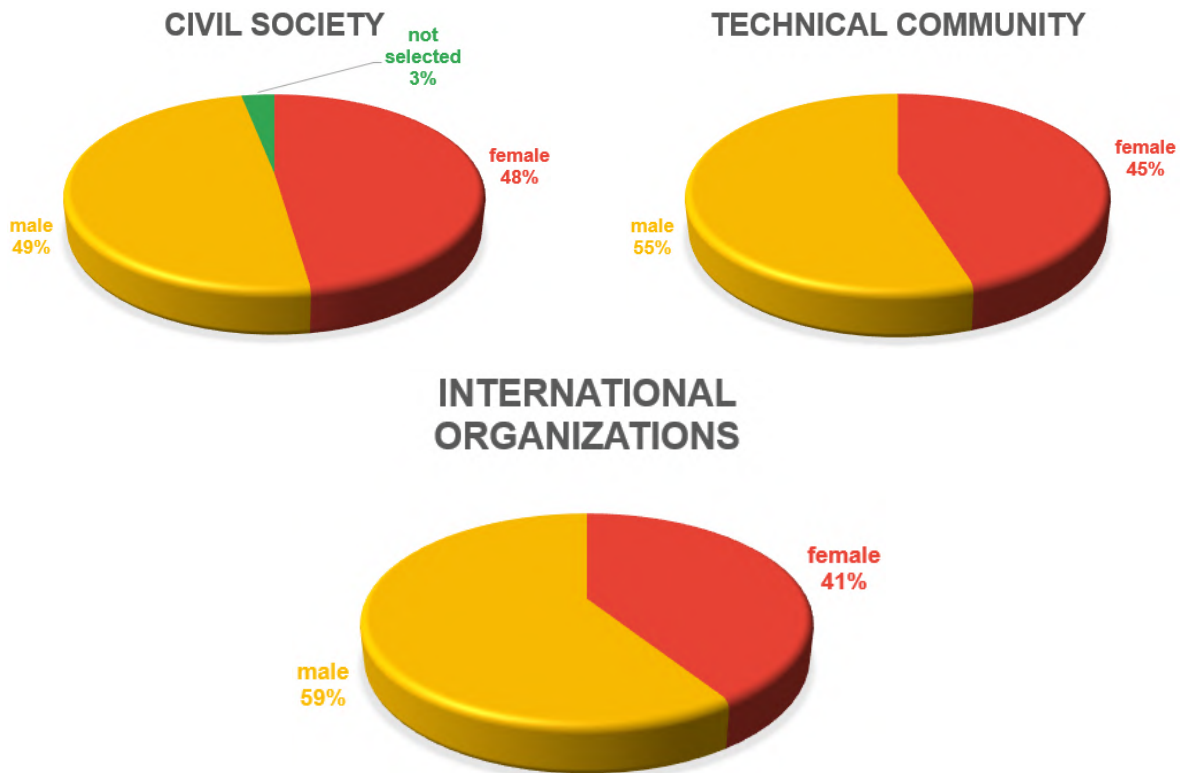
GENDER REPRESENTATION BY STAKEHOLDER GROUPS

GOVERNMENT



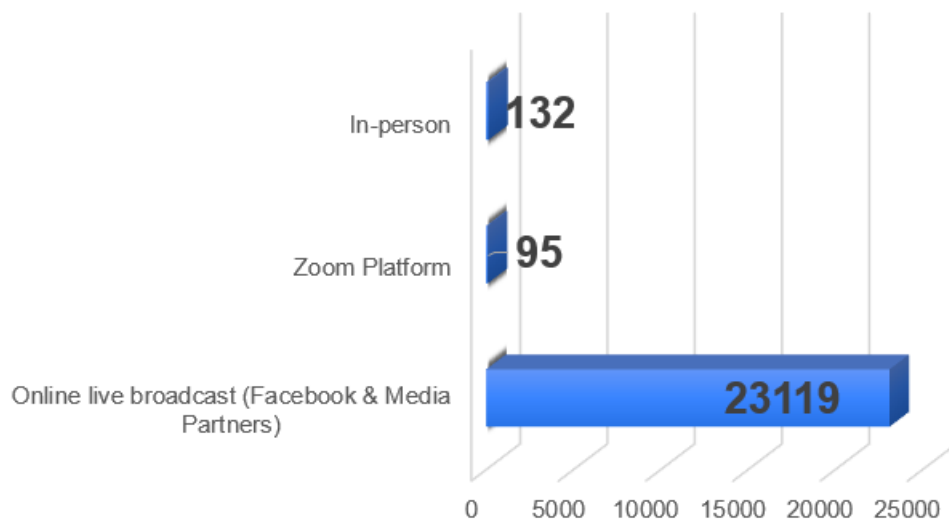

ATTENDANCE STATISTICS OF THE MEETING

During April 29-30 most of the Forum audience joined the event in the live format on social media and through online television. In total, according to the statistics of the Facebook platform and media partners broadcasting the event, 23119 participants joined the live online broadcast (unique connections). By connecting to the online platform Zoom, which provided simultaneous interpretation in Romanian, Russian and English, the Forum was attended by 95 people. In-person, 132 registered participants took part in the sessions of the event over two days.



FINANCIAL ISSUES



The necessary resources in the preparation and holding of the Forum were provided by the Organizers, Partners and Sponsors of Moldova Internet Governance Forum. The meeting took place in a low-cost manner, having received in-kind and/or financial support from the international organizations, public institutions, national partners of the event, as well as the Organizing team and the wider community. No payment has been provided for any speakers.

- Designing conception of the event and branding related activities (creation and integration of Forum and other printing materials, conducting surveys among the members of the community, roll-up 80x200, banner 4000x2500, logo, badge, program markup, etc.);
- Online promotion (web banners, news and social media), the development of informational materials, as well as outreach activities toward the broader community of the country;
- Organizational space preparatory works (searching for and selection of space, conference hall, technical equipment, etc.);
- Rent of the technical equipment for Zoom sessions support and moderation, online platform settings, testing and event online platform technical support;
- Conference simultaneous interpreting and Interpretation facilities (2 days, 3 languages – Romanian, Russian, English);
- Catering and coffee breaks during 2 days of the event;
- Printing activities (searching and selection of printing company, badges, event agenda, banners and roll-ups);

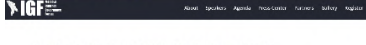





This year's MIGF agenda included discussion of key aspects of digital infrastructure development, regulation in the era of technological innovation and digital sustainability, as well as legislative and policy challenges to internet freedom in Moldova. 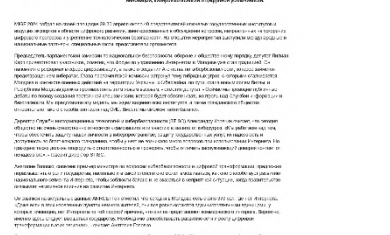
