UPDATES FROM THE WORKING SESSION

17 June 2020

1. Subthemes

The WG updated subtheme 3 from Design & Policy for Social Inclusion and Environmental Sustainability to Design & Policy for Social Inclusion.

- 1. Local Content & Language Diversity
- 2. Availability, Affordability & Access of Infrastructure
- 3. Design & Policy for Social Inclusion
- 4. Digital Literacy & Capacity Building
- 5. Digital Economy & Emerging Technologies
- 6. Governance & Policy

2. Proposed Workshops to be approved.

The WG updated its workshop shortlist as follows.

- Top 20 WS that scored 4 and above.
- WS 107 and WS 248 (ranked 21 and 22 respectively) on condition of merger.
 Both workshop address education with one focusing on e-Learning: how to tackle accessibility challenges online and the other Educational Opportunities & Challenges in Times of Crisis bringing the voice of the GRULAC region (WS 107) on e-Learning with that of current pandemic (WS 248).
- WS 122 and WS 20 (ranked 23 and 25 respectively) on condition of merger.
 Both workshops address languages but from two different perspectives, with WS 122 addressing
 Data to Inclusion: Building datasets in African Languages and WS 20 addressing Exploring the future of endangered languages in cyberspace.
- WS 37 ranked 28 bringing thematic balance to the Availability, Affordability & Access of Infrastructure subtheme
- WS 289 ranked 29 bringing thematic balance to the Design subtheme Design & Policy for Social Inclusion and Environmental Sustainability.






Two sets of mergers from the yellow basket have been proposed, as noted in the section above.
