## INTRODUCTION

The Canadian Internet Governance Forum (CIGF) – previously operated as the Canadian Internet Forum from 2011-2016 – is the National Initiative for Canada. The CIGF held its first conference in 2019. The CIGF offers the Canadian internet community a chance to discuss the most pressing and timely public policy issues facing the internet and empowers the community by ensuring their priorities are shared on the global stage at the United Nations global IGF.

This report provides operational and planning details for the 2023 CIGF: The Future We Want, held on October 4<sup>th</sup> at the Centre de recherche informatique du Montreal (CRIM). A subsequent policy report will be published detailing the discussion insights and policy priorities of the Canadian internet community from the event.

#### PREPARATORY PROCESS

The preparatory process for the 2023 CIGF involved nearly a dozen meetings from the multistakeholder All-Hands Committee, work by the Secretariat, CIRA, and support from an events management firm. It is open, inclusive and non-commercial in organizational structure and process development. These are the highlights of the preparatory process:

- # of All-Hands Committee meetings: 10
- **Outreach with wider community:** the All-Hands Committee includes representatives from each of the Canadian internet community's stakeholder groups. Members draw on their individual networks to inform the program design.
  - The CIGF's website has a form for the public to recommend topics, which are tabled by the Secretariat to the All-Hands Committee.
  - Post-event surveys from the #CIGFTalks speaker series from 2021 2023 provided a chance for the broader community to provide input on desired topics for future meetings.


## AUDIENCE BREAKDOWN

## AUDIENCE FEEDBACK

Audience feedback for the 2023 CIGF was overwhelmingly positive. It was collected orally on the day of, through social media engagement and via Survey Monkey in the week following the event.

Attendees rated the speakers as informative, authoritative and engaging. They viewed the sessions as timely and interesting. They also reported enjoying the networking opportunities across sectors.

Government stakeholders were appreciative of CIGF's convening power to provide input on key internet policy issues.

The Committee and its partners were pleased to convene the Canadian internet community in person for the first time after three years of online-only events and are keen to grow it ahead of consequential global internet governance dialogues, such as the World Summit on the Information Society (WSIS)+20.

The committee agreed that the 2024 (and subsequent) CIGFs can be improved by modernizing the conference website and communicating key conference details (including the date and location) earlier.

### BUDGET

The CIGF is funded through a sponsorship model. It is largely funded by its Secretariat and historic presenting sponsor, CIRA. This year, the CIGF was also sponsored by TikTok Canada, ICANN and CANARIE. The Applied AI Institute provided an in-kind contribution of two note-takers, whose notes help inform the subsequent policy report. CRIM was a partner for providing the venue at a discounted rate.

The Quebec IGF was also a partner for co-promotion, liaising and coordinating on agenda, and sharing the CRIM venue.
