# Who we are

Established in 2007, the Internet Governance Forum Spain (IGF Spain) is an open and decentralized space that aims to foster the debate of public policy issues relating to the Internet. It draws inspiration from the Internet Governance Forum (IGF), established by the United Nations Secretary General in 2006. The IGF Spain is chaired by Prof. Jorge Pérez Martínez and provides a multistakeholder platform that brings together people from various stakeholder groups on equal footing (representatives of the civil society, government, the private sector, the academia, and the technical community). It is meant to elevate the voice of the Spanish society to the international fora of internet governance.

The funding of the IGF Spain comes from the corporate sponsorships of Fundación Telefónica, Vodafone, Google, Orange and TikTok, and in-kind collaboration of other entities, such as the Universidad Politécnica de Madrid<sup>1</sup> (UPM) and the Secretary of State for Telecommunication and Digital Infrastructures.

## Structure

The IGF Spain is supported by a Multistakeholder Advisory Group, whose members belong to different organizations within the government, the private sector, the civil society, and the technical and academic communities.

The Multistakeholder Advisory Group is open to anyone willing to engage in the activities of the forum. Other entities, such as civil society (Asociación de Internautas, Anei, Cibercotizante, Cibervoluntarios and Asociación de usuarios de Internet) and corporate associations (Ametic and DigitalES), are also engaged in the working groups and help to distribute the messages of the forum. The Multistakeholder Advisory Group holds regular meetings throughout the year.

The Multistakeholder Group select the topics and helps define the working groups, which are in charge of finding the panelists and the focus of the debate.

## Youth IGF

The Youth IGF Spain aims to be a multidisciplinary space for dialogue where all the young people in Spain can share their vision and expectations about the future of the Internet. It was created on September 2022, and so far has 33 members from different disciplines and universities from Spain, including telecommunications and public relations.

So far, we have had different activities to promote the initiative:

1. Competition to create the poster and motto of the IGF Spain 2023
2. Competition sponsored by the association DigitalEs under the theme: “Salud mental de los jóvenes contra el uso de redes sociales y videojuegos” (Youth Mental Health vs use of social media and videogames). The prize is a trip to attend the European Dialogue on Internet Governance 2024 in Vilnius as part of the YouthDIG.  
The competition was structured in two phases, the first where the participants had to create a short video, which were later judged by our sponsor and by the IGF Spain. The four bests were selected for a debate which will take place on the 29<sup>th</sup> of November, the day dedicated to the Youth IGF Spain.
3. Competition sponsored by the association Adigital under the theme: “Construyendo la confianza en la era de la Inteligencia Artificial: Navegando la ética, la seguridad y los sesgos” (Building trust in the era of Artificial Intelligence: Ethics, security and bias). The prize is a trip to attend the European Dialogue on Internet Governance 2024 in Vilnius as part of the YouthDIG.

## Annual meeting preparation

### Working groups

The Spanish IGF annual meeting 2023 is a two-day hybrid event (face-to-face and online) held at Polytechnical University of Madrid with different sessions in a structured program with several roundtables. All the talks had the aim to cover the most relevant and interesting issues in the field of internet governance. These sessions were organized by the working groups, which are built annually at the beginning of the year to work in the organization of the annual event.

The members of each working group are representatives of different stakeholder groups: public sector, private sector, academy, and civil society represented in different NGOs.

### Communication & Dissemination

The Secretariat designed and implemented a strategic plan for the general communication of the event. it was worked in five lines:

- Contact and articulation with the experts and exhibitors for the different presentations and for the main conferences.
- Dissemination to favor the participation in the event.
- Contact with organizations from de human and social field to amplify the discussion and the interaction.
- Articulation with press and journalists to amplify the presence in the mass media and to prepare the management of roundtables for the event day.
- Increase the presence in social networks.

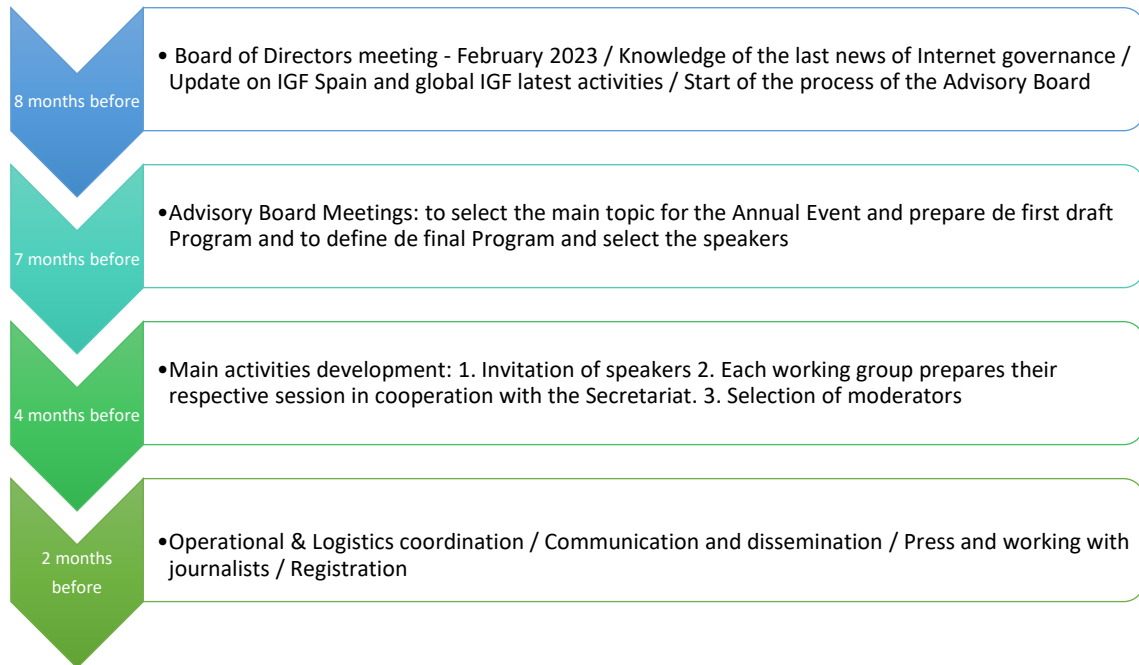


## Web and Social Media

## Session 2. Net neutrality.

The proposal for large internet platforms to help finance telecommunications infrastructure is giving rise to a debate about its effect on net neutrality. There are very conflicting positions on the subject. Opponents believe that it would lead to unfair treatment of content that would violate the principle that has favoured the rapid introduction of new services and innovation on the Internet, while proponents do not see this problem and argue that it would contribute to the development of better communications networks. This session will analyse the views of industry players on this topic.

## Participation in the annual meeting

The 2023 Spain annual meeting has chosen a hybrid format. It has reached 236 registered participants.

## Summary of main messages.

This summary has been prepared considering the talk of Jorge Pérez in the closing ceremony and the document from Isabel María Alvaro Alonso<sup>2</sup>.

- The European telecommunications sector is witnessing a decline in both its size and global competitiveness, raising concerns about falling behind the global technology forefront. The persistent fragmentation of the European market has become a chronic issue, emphasizing the need for local scalability to ensure economic sustainability. In order to foster a thriving digital ecosystem, it is imperative to implement measures that guarantee economic viability and ensure the availability of modern communication infrastructures, facilitating the growth of digital services.
- Net neutrality is a universally recognized and embraced concept within the industry. In contrast to other regions worldwide, Europe enforces stricter net neutrality regulations, which, in some cases, may restrict innovation.
- In a sector where calls for minimal regulation are common, there is a growing demand for specific regulations concerning artificial intelligence. The complexity and far-reaching impacts of AI generate significant uncertainties. Europe a pioneering force in addressing these challenges.
- Although Europe may not lead in the technological development of Artificial Intelligence, substantial opportunities for its application across various economic sectors await exploration. Ensuring equitable access to the datasets required for AI systems is essential.
- Preserving online freedom of expression hinges on transparency in content management algorithms and the responsibility of platforms to manage content appropriately. Differentiating the treatment of media, influencers, and individual citizens' content is crucial.
- It is necessary to properly differentiate the treatment given to the content of the media, influencers and citizens.
- Developing digital rights comprehensively and ensuring their effective defense in an increasingly digital world is an ongoing journey. Spain holds an advantage with its digital rights charter, and Europe has a significant role to play in promoting these rights on a global scale.

# Course on Governance of the Digital Ecosystem and Internet

An online course has been organized from September 18 to 28, 2023 in collaboration with the Universidad Europea del Atlantico.

The objective of the course is to provide a holistic vision of the digital ecosystem and the Internet that allows students to acquire updated knowledge about their governance, the agents involved, the context in which they move and the European and Spanish regulations that affect them.

The course is aimed at undergraduate, master's and doctoral students of any degree related to technologies, as well as professionals, who wish to acquire knowledge about the Governance of the Digital Ecosystem and the Internet.

The course consists of 14 topics structured in 5 modules and a complementary activity of assistance to the IGF Spain Annual Meeting. The following is the course program.

## Module 1. Analysis of the context.

- 1.1. From the Internet to the global digital ecosystem.
- 1.2. The regulation of the open Internet: net neutrality and level playing field.
- 1.3. Privacy and security in the post-Snowden era.

## Module 2. Digital vs. Digital Sector Digitalisation of the economy and society

- 2.1. Definitions and characteristics of the digital ecosystem/sector.
- 2.2. Digitalisation and the digital transformation of the economy and society.

## Module 3. Next regulation in Spain

- 3.1. Regulation of telecommunications. The general telecommunications law.
- 3.2. Regulation of content in Spain. General Law on Audiovisual Communication, Protection of Intellectual Property and New Agents in the Media System.
- 3.3. Regulation of trust and security in telecommunication networks. 5G cybersecurity law.

## Module 4. Emerging European regulation

- 4.1 Social Media Governance. Digital rights in the Digital Services Regulation (DSA).
- 4.2 Regulation of platforms in the Digital Markets Regulation (DMA).
- 4.3 Artificial Intelligence: can you put doors to the field?
- 4.4 European framework for the regulation of telecommunications networks and digital services.

## Module 5. European Digital Sovereignty in a context of geo-politicization of the economy.

- 5.1. The political dimension of digital citizenship: the challenges of democracy
- 5.2. The context of sustainability and climate change in Europe, and its relationship with digitalisation.

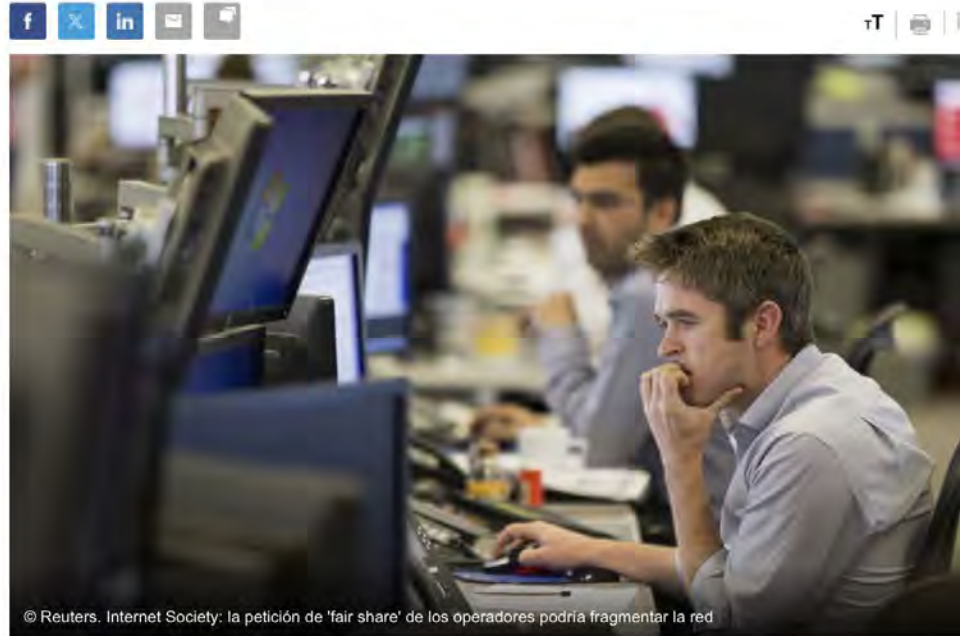

## EL PRESIDENTE DE CINTAC HA PARTICIPADO EN LAS JORNADAS ANUALES DEL FORO DE LA GOBERNANZA DE INTERNET EN ESPAÑA



El presidente de CINTAC, Juan Carlos Ramiro, ha participado en la XIII edición de las Jornadas Anuales del Foro de la Gobernanza de Internet en España.

La mesa trataba de "Derechos digitales para la generación conectada", donde se conversó sobre la declaración europea de derechos y principios digitales, así como de la carta española de derechos digitales.

"Los derechos digitales son un plan que tiene como objetivo que los ciudadanos se sientan seguros e incluidos en internet. Se engloban dentro de 6 áreas: las personas como centro de transformación digital; inclusión; libertad de elección; participación en espacios públicos; sostenibilidad; y seguridad y empoderamiento.

Dentro de este último, es donde podemos ver especialmente mencionados a los jóvenes: la importancia de que tomen decisiones seguras y que se garantice su bienestar y seguridad online", declaró Pilar Rodríguez, moderadora de la mesa.

España ha sido pionera en los derechos digitales. Fue el primer país europeo que publicó una carta de derechos digitales en la que de nuevo vemos artículos dedicados a los menores destacando así la importancia que tienen como grupo vulnerable dentro de Internet.

Carlos Romero Duplá expuso la idea de que es importante ir extendiendo el reconocimiento de estos derechos en las normativas que se van adoptando como, por ejemplo, a través de los paquetes de servicios digitales y, también, a través de la implicación de las plataformas de las redes sociales, mediante corregulación y su involucración.

Moisés Barrio Andrés manifestó que es esencial conseguir que la regulación europea sirva de ejemplo y modelo a nivel mundial y, por tanto, alcanzar un equilibrio entre un progreso tecnológico pero también el respeto de los derechos de los ciudadanos.

"Todas las tecnologías son grandes oportunidades que por supuesto tienen retos y todos podemos jugar un papel clave en ayudar a que esas oportunidades sean mejor aprovechadas y a garantizar que sean más accesibles. Es fundamental adaptar la conversación a todos los públicos y que sea accesible", declaró Jesús Cordero González.
