SUMMARY REPORT

Action Items:

- NRIs coordinators share ideas for the NRIs coordination session title.

1. The eleventh virtual meeting of the NRIs in the IGF 2024 preparatory cycle took place on 18 November 2024 at 14:30 UTC. The meeting was hosted by the IGF Secretariat's NRIs Focal Point. The final adopted version of the Agenda is attached as Annex A1, the list of meeting participants as Annex A2, and the list of meeting inputs as Annex A3.
2. The meeting was convened to finalize the NRIs main session and coordination session, both hosted at the 19th annual IGF meeting in Riyadh, scheduled for 15-19 December 2024.

Summary of points

3. Participants discussed the flow of the NRIs main session. It was agreed that the onsite and online moderators will consult with the speakers of the first segment to understand the policy questions they intend to address. Based on these discussions, the moderators will determine the speaking order and update the draft annotated agenda.
4. The IGF Secretariat will facilitate this preparatory call between the moderators and first segment speakers, and invite all NRIs to join on an optional basis. After finalizing the discussions, the updated script will be shared with the NRIs mailing list for review and endorsement.
5. During the NRIs main session's second segment, it was agreed that the session participants will be allowed to sign up for interventions, each limited to two minutes. Moderators will softly remind speakers when their time is up. The IGF Secretariat is exploring the feasibility of implementing a visible timer in the room to assist with time management.
6. As an additional mode of participation, the session participants will be encouraged to provide written inputs via the chat feature to maximize efficiency and save session time.
7. Rapporteurs will be tasked with drafting action-oriented messages as part of the session report. These messages will be made publicly available for community review and commenting after the IGF concludes.
8. Regarding the NRIs coordination session hosted on 15 December, it was agreed that significant portion of the session will be dedicated to the agenda item 3: NRIs' role in the

context of WSIS+20/IGF+20 and the Global Digital Compact (GDC).

9. The IGF Secretariat will ensure a smooth transition from agenda item 2: Evolution and Impact of NRIs to the third item on the NRIs' role in WSIS+20/IGF+20 and the GDC.
10. NRIs are encouraged to submit written inputs in advance, particularly examples of their impact, which will help reference relevant sources during the discussion and save time.
11. A soft time limit of 3.5 minutes per intervention will be observed to ensure balanced and effective participation.
12. The session title will be updated to reflect the inclusion of the GDC. The current title, "*What NRIs Could Do for WSIS+20?*", will be revised. NRIs are invited to suggest new title ideas as soon as possible.
13. Due to time constraints, updates on the status of other NRIs collaborative sessions will be communicated via the NRIs mailing list.

Next Steps

14. The IGF Secretariat will circulate the action points for final endorsement on the NRIs mailing list.
15. A doodle poll will be sent for scheduling a call with the NRIs main session moderators and speakers.
