# Online Meeting 22 16 September 2021 at 1 p.m. UTC

The 26<sup>nd</sup> virtual meeting of the IGF MAG's Working Group (WG) on IGF Strengthening and Strategy (WG-Strategy) was held on 16 September 2021 at 1 p.m. UTC. The goal is to have 1:1 mentorship so that the youth participating can advocate on the issues they are standing for.

## 4. Table mapping

For the moment, the table is up to date (although it is of course a rolling document). It was highlighted to discuss the follow up activities and how this work could be presented in the IGF event. Titti Cassa discussed the next steps, such as the possibility of including the mapping table in the Wiki page.

Wim Degezelle was asked about the thinking behind the Wiki page. He said the purpose of the Wiki page was to collect information on what is going on with the IGF 2021 program in the six main areas of the IGF, and what's going on outside and bringing it into one place. He also stated that by the time the IGF starts in December, the wiki page will be complete. After that, it will be archived. Finally, he said that we need to think further about integrating the mapping exercise, as the idea is to work with the issues areas and then work in the communities.

# 5. Update on behalf of the Envoy on Technology

Jason Munyan updated the participants on the activities related to digital cooperation in the framework of the upcoming UN General assembly. He mentioned that digital public goods will have events related to open source and open software. The World Bank is also doing a study about capacity building and may reach IGF members to share the results of this research.

In speaking to parliamentary assembly of the Council of Europe, UN High Commissioner for Human Rights Michelle Bachelet on Wednesday stressed the urgent need for a moratorium on the sale and use of artificial intelligence (AI) systems that pose a serious risk to human rights until adequate safeguards are put in place. She also called for AI applications that cannot be used in compliance with international human rights law to be banned.
