Action points – Activities in 2022

1. Annual Global Digital Health Survey

Digital Health is fuelling a revolution in the healthcare industry. COVID-19 has highlighted the importance and need for digital health interventions. Healthcare is becoming more accessible, affordable, and outcome-driven as a result of advances in digital health.

A global online survey was conducted on the SurveyMonkey platform. The survey ran from September 5, 2022, to January 18, 2023. A total of 302 responses were received from 58 countries worldwide. The survey was promoted on various social media platforms as well as through the DC-Digital Health stakeholders' network with an aim to analyze and comprehend people's basic knowledge of Digital Health, as well as to raise awareness about it and gauge their willingness to use these interventions to seek medical assistance.

2. Global Digital Health Summit, Expo, and Innovation Awards 2022

India's first-ever Global digital health Summit, Expo & Innovation Awards was hosted by Digital Health Associates in association with Internet Governance Forum-Dynamic Coalition

on Digital Health at Vigyan Bhawan, New Delhi on the 28th and 29th of October 2022. The massive summit saw attendance of more than 700 healthcare delegates across continuum of care.

Dr. Jitendra Singh, M.B.B.S., M.D.- Hon'ble Union Minister of State, Prime Minister's Office, Government of India as the Chief Guest graced the summit. With a unique and esteemed line-up of world-renowned healthcare leaders and digital health practitioners as speakers, the most important and pressing issues were discussed. over the course of two days, from addressing the 'Return on Investment in Digital Health' to 'Digital Health Adoption', 'Digital Health Start ups', and 'Emerging Digital Health Technologies', six hard-hitting & insightful panel discussions took place. Certificate Masterclasses were held with the world's foremost leaders in digital health. Rt. Hon Patricia Scotland KC, Secretary General of the Commonwealth, also delivered remarks.

The Global Digital Health Awards received an overwhelming response. Our esteemed jury shortlisted 35 innovative applications after several rounds of screening. Out of the shortlisted nominees, at the summit, 15 ground-breaking and innovative healthcare start-ups and organizations were facilitated with the "Global Digital Health Innovation Awards 2022."

The global summit gave 21 exhibitors a rare opportunity to showcase their work to global leaders and healthcare experts.

The summit was a huge success and provided various stakeholders with a unique platform to network, share, and create ideas that will boost the adoption of the digital health mission in India.

3. IGF 2022 Ethiopia conference- Digital Health Academy booth

IGF-DC on Digital Health put an exhibition stall at the 17th Internet Governance Forum in Addis Ababa, Ethiopia. The work was presented to global leaders by Dr. Rajendra Pratap Gupta.
