Meeting II | 22 June 2023 at 13:00-14:00 UTC

SUMMARY REPORT

Action items:

- Register to join one of the three PNAI report drafting teams.
- Penholders of the drafting teams will invite for the first calls of the teams to start the work.

1. The second virtual meeting of the Policy Network on Artificial Intelligence (PNAI) took place on 22 June 2023 at 13:00 UTC.
2. The meeting was hosted by the IGF Secretariat's PNAI Consultant and the two MAG facilitators of the PNAI. The final version of the Agenda is attached to this document as Annex A1 and a list of meeting participants as Annex A2. The list of shared documents is annexed as A3.
3. The hosts opened the meeting by reminding, that the objective of the meeting is to form drafting teams to lead the work in developing the three chapters of the PNAI report.
4. The draft PNAI report outline was presented. A team of volunteers has worked on the outline following the initial PNAI meeting held in May.
 - The report will take a Global South perspective, another cross-cutting theme is generative AI.
 - The three report chapters are: Global interoperability of AI governance, AI and gender / race, and Environment and AI.
 - Drafting the report will start in dedicated drafting teams each responsible for one chapter and topic.
5. Representatives of the drafting teams presented their topics and received comments and suggestion from the meeting attendees. Key points of the discussion are summarized below:
 - 'Environment and AI' team shared tentative topics that they will develop further. Attendees found the approach where data governance is the starting point for the work beneficial. It is important to note that analyzing and gathering data also demands great amounts of energy.



- The challenge that 'Global interoperability of AI governance' team explores is ensuring the different AI regulatory frameworks are compatible with each other. The audience pointed out that different countries and regions have different needs and priorities in regulating AI, a few countries benefit from the wealth generated by AI, while others face the environmental and human rights risks.
- 'AI and gender / race' team will look into how policy making helps address the AI issues related to race and gender around the world.
- The meeting attendees were encouraged to sign up to join the three teams.

7. Penholders of the drafting teams will convene the first meetings of their teams.
8. The next PNAI meetings will take place on 4.7.2023 at 14:00-15:30 UTC and 18.7.2023 at 13:00-14:30 UTC.
