Meeting II | 30 May 2024 at 11:00-12:00 UTC

SUMMARY REPORT

Action items:

- Amrita and Audace will circulate a draft of Global Digital Compact input for comments through the PNAI mailing list in the following days.
- The joint deadline for draft versions of Discussion papers is Tuesday 1.10. and deadline for Discussion papers is Friday 25.10.
- Sub-groups will plan their own work, timeline and outline templates in meeting materials will help.
- The next PNAI MWG meeting will take place on Friday 21.6.
- The 2024 PNAI MWG calls are planned for the following dates: 21.6.; 24.7.; 12.9.; 10.10.; 22.10.; 21.11.; and; 6.12.

1. The second online meeting in 2024 of the Policy Network on Artificial Intelligence (PNAI) Multistakeholder Working Group (MWG) took place on 30 May 2024 at 11:00 UTC.
2. The meeting was hosted by the two MAG facilitators of the PNAI and the IGF Secretariat's PNAI Consultant. The final version of the Agenda is attached to this document as Annex A1 and a list of meeting participants as Annex A2. The list of shared documents is annexed as A3.
3. The hosts opened the meeting and reminded that the goals of the meeting were to discuss PNAI input to global AI governance consultations,
4. The first agenda item was a discussion on PNAI input to AI governance consultations. One of PNAI's goals for 2024 is providing input to global AI governance consultations. It was agreed that PNAI will prepare input to the Global Digital Compact. Amrita and Audace will circulate a first draft for comments through the mailing list in the following days.
5. A presentation on the planned timeline and deadlines for preparing PNAI Policy Brief followed. The Policy Network will deliver a Policy Brief report before IGF 2024 Annual meeting in December. PNAI Sub-groups draft Discussion papers, the concise Policy Brief will be created based on them.
 - Sub-groups are free to organize their work as they see best but are strongly encouraged to set team deadlines/check points. A timeline template is included in meeting materials. It was suggested that Sub-group outputs should follow similar structure. Sub-group



team leads have received an Outline structure example in May, and it is available in meeting materials.

- The most important joint deadlines for PNAI community are:
Deadline for draft versions of Discussion papers 1.10.; Deadline for Discussion papers 25.10.; Deadline for draft version of the Policy Brief 7.11.; and Deadline for Policy Brief 2.12.
 - The 2024 PNAI MWG calls are planned for the following dates: **21.6.**; **24.7.**; **12.9.**; **10.10.**; **22.10.**; **21.11.**; and; **6.12.**
 - Changes are possible and the updated information on important dates is always available on PNAI web page.
6. The four thematic Sub-groups that were established in the previous meeting gave first updates on their work:
- **Labour issues within AI's life cycle** has held their first meeting and shared first impressions of their topic through PNAI mailing list. Germán López shared that group is working on defining AI life cycle and the role of Internet governance. Attendees commented on the importance of Global South perspective and the question of Artificial General Intelligence.
 - Caroline Friedman Levy shared the progress of **Liability as a mechanism for ensuring AI accountability**. The group has also held their first meeting and focused on proposed outline and clarifying what liability means. An outline was shared through PNAI mailing list.
 - **Environmental Sustainability and the AI value chain** Sub-group has held their first meeting and set a recurring meeting every second week. A chapter outline was shared for comments through PNAI mailing list.
 - **AI governance, Interoperability, and Good practices** Sub-group was not present in the call and is asked to share a short update on their progress through PNAI mailing list.
 - Links to materials shared by the groups are annexed. Those who would like to join the Sub-groups can email Maikki or the Team leaders.

8. The next PNAI MWG calls will take place on 21.6. and 24.7.
