## The Contribution of Parliamentarians to the Internet We Want: An Asia Pacific Perspective

Concept note

### **CONTEXT**

The Internet Governance Forum (IGF), convened annually by the UN Secretary-General, is a global multistakeholder platform that facilitates discussions on Internet and digital policy issues. This year, the Government of Japan will host the United Nations 18th Internet Governance Forum (IGF 2023) under the overarching theme "The Internet We Want – Empowering All People".

The Pacific (PACIGF) and the Asia Pacific IGF (APrIGF) are regional IGF initiatives dedicated to fostering exchanges within the region on relevant digital policy topics. In recent years, the IGF has sought to strengthen the participation of parliamentarians in discussions on some of the most pressing issues related to the use, evolution and governance of the Internet and related digital technologies.

Building on last year's parliamentary track experience, the IGF plans to further strengthen its parliamentary track through expanding its regional activities. With the annual IGF meeting scheduled to be held in Japan, a special focus will lie on the engagement with national parliamentarians in the Asia and Pacific region.

In line with this goal, a symposium dedicated to parliamentarians from across the Pacific and Asian Pacific region is to be held in the context of the 2023 APrIGF meeting, under the overarching title "The Contribution of Parliamentarians to the Internet We Want: An Asia Pacific Perspective".

#### **DESCRIPTION**

The initiative is focused on facilitating dialogue and exchanges on key digital policy issues among Members of Parliaments (MPs), and between MPs and other stakeholders from within and beyond the Asian continent.

## **Target audience**

 The symposium is dedicated to members of national parliaments from Asian and Pacific countries and members from other regions who would like to attend or contribute. Focus will be given to the Parliamentarians in the information and communication technology (ICT) related committees at the national or regional parliaments, who work on digital affairs and Internet policy issues.

### **Objectives**

- Familiarize MPs with the IGF space and the broader international ecosystem for Internet governance and digital policy. Encourage them to actively contribute to relevant regional and international processes.
- Prepare MPs for participation in the IGF 2023 meeting and the dedicated parliamentary track, as well as future IGF meetings and activities.



- Update MPs on a set of Internet governance and digital policy issues relevant to Asian Pacific countries. Facilitate dialogue on these issues with other parliamentarians from around the world, as well as with relevant international and regional organisations from different stakeholder groups (intergovernmental organisations, the technical community, private sector, civil society).
- Discuss the relevance of legislative work in shaping the region's digital future. Highlight issues
  that need to be considered when legislation for the digital space is developed (e.g., avoiding
  unintended consequences for the open and global nature of the Internet).
- Facilitate cooperation and exchanges of good practices with MPs from national and regional parliaments, as well as parliaments from other regions, which have advanced legislative work on digital policy issues.
- Expose the MPs to the various digital-related UN: Agenda 2030, the Roadmap for Digital Cooperation, the Our Common Agenda Report, the Global Digital Compact.

### Co-organizers

The symposium is co-organised by the UN Department of Economic and Social Affairs (DESA),
 the IGF Secretariat, the Australian Government and the PACIGF and APrIGF Secretariat.

Parliamentarians from the region are invited to discuss the proposed issues with experts, share their views, explore the questions at hand, and exchange opinions and experience on existing or potential legislative solutions.

The key messages that emerge from the regional parliamentary track exchanges will be captured as the formal, action oriented regional IGF 2023 parliamentary track output.
