

## 5. IGF 2024 Call for Session Proposals: <u>15 March – 30 April 2024</u>

- All stakeholders are invited to submit proposals to hold workshops at the forthcoming IGF, as well as other potential session types: town halls, open forums, networking sessions, lightning talks, individual sessions by IGF Dynamic Coalitions (DCs), collaborative sessions by National, Regional and Youth Initiatives (NRIs), proposals for 'pre-events' on Day 0.
  - Submission of proposals: 15 March 30 April 2024
- Secretariat analysis of proposals: 1 6 May 2024
- Submission of workshop proposals to the MAG for evaluation: 7 May 2024

## 6. IGF 2024 Call for Village Exhibition Booths: <u>15 March –</u> 30 June 2024

During the annual IGF meeting, interested stakeholders can display or distribute relevant information about their IGF-related activities at the IGF Village. The booths are non-commercial in nature, free of charge, and allocated on a first-come, first-served basis, respecting a balance of stakeholder and regional diversity. Booths are of limited availability.

#### 7. IGF 2024 Call for Remote Hubs: <u>15 March – 30 July 2024</u>

Invitation to all stakeholders interested in organizing a remote hub. Hubs are local meetings that take place in parallel with the IGF. People can watch the webcast of IGF sessions together and send interventions (via text, audio or video) that can be answered by panellists in IGF.
