"IGF to GDC: An Equitable Framework for Developing Countries"

Background

The United Nations Internet Governance Forum (IGF) brings together stakeholders from various sectors to discuss digital public policy. While it does not produce negotiated outcomes, the IGF informs and inspires policymakers in both the public and private sectors. The IGF operates year-round, engaging in policy, outreach, and community and capacity-building activities. These efforts aim to foster a common understanding of how to maximize digital opportunities and address digital risks and challenges. The IGF's intersessional work culminates in annual meetings where delegates discuss critical issues, share best practices, and exchange policy recommendations. The outputs from these meetings are shared with global and national decision-making bodies.

The IGF plays a pivotal role in the development and promotion of the Global Digital Compact. As a platform that brings together a wide range of stakeholders, the IGF provides a unique space for dialogue and collaboration on digital governance issues. The discussions and insights generated at the IGF contribute to the shaping of the Global Digital Compact by highlighting the diverse perspectives and needs of different sectors and regions. The IGF's inclusive and transparent approach ensures that the principles of the Global Digital Compact are informed by a broad and representative range of voices, making it a truly global initiative

Objectives

This workshop aims to foster dialogue and collaboration between the IGF and the Global Digital Compact (GDC), focusing on equitable digital development for developing countries. The session seeks to bridge the gap between the IGF and the GDC, emphasizing practical solutions and equitable digital development. By fostering cooperation, we can create a more inclusive and impactful global digital ecosystem. Additionally, the session will provide a preview of the 19th IGF, scheduled to take place in Riyadh, Kingdom of Saudi Arabia, from December 15-19, 2024.

Key Themes

 Harnessing Innovation and Balancing Risks in the Digital Space: This theme will explore how to leverage technological advancements while managing associated risks. It emphasizes the need for innovative solutions that drive progress without compromising security and privacy.



- Enhancing the Digital Contribution to Peace, Development, and Sustainability: This theme focuses on the role of digital technologies in promoting global peace, fostering sustainable development, and supporting humanitarian efforts. It highlights the potential of digital tools to create positive social and environmental impacts.
- Advancing Human Rights and Inclusion in the Digital Age: The 2024 IGF will emphasize the importance of protecting human rights and promoting inclusion in the digital era. This theme will address how digital technologies can be used to ensure equitable access and participation for all individuals, particularly marginalized communities.
- Improving Digital Governance for the Internet We Want: This theme will discuss strategies for enhancing digital governance to create a more inclusive, transparent, and accountable internet. It will explore frameworks and policies that support the development of a fair and open digital ecosystem.
