1. Updates from the Secretariat and final preparations for the first open consultations and MAG meeting

- The registration platform closed on 17 February with over 380 registrations (both onsite and online). For those attending online, there will be a Zoom link shared by the end of the week and posted on the [event webpage](#) of the IGF 2024 First Open Consultations and MAG Meeting.
- The Secretariat is in close contact with the host country regarding any support required to obtain a visa.

2. Revised MAG WG on Youth Engagement and updates from the MAG Working Groups

- The new [working group proposal on Youth Engagement](#) has been introduced and selected.
- The facilitators of the other MAG WGs provided an update:
 - The WG on Strategy, which initiated the draft MAG response to the CSTD questionnaire, has received input from Dynamic Coalitions and the Leadership Panel. The WG Strategy will meet on 22 February to finalize the MAG response to submit by the end of the week. The WG on Strategy will also discuss any potential comments to the LP [Internet We Want](#) paper by 1 March.
 - The WG on Workshop Process updated the [IGF 2024 workshop Proposal Form](#), as well as the [IGF 2024 Workshop Manual](#) for the MAG's consideration at the face-to-face MAG meeting in Riyadh. The documents should then be finalized to launch the call for session proposal on 15 March 2024. At the face-to-face meeting, the taking stock from IGF 2023 and the programme structure including the numbers and types of sessions will be discussed. It was suggested to provide a draft proposal of an IGF 2024 programme structure (number and types of sessions...) as a basis for discussions at the face-to-face meeting. The venue remains flexible to increase or decrease the overall room capacity.
 - The WG on Multilingualism plans to operate very independently with no regular meetings required. The facilitator suggested to meet in Riyadh and online.
