Teen Contributions

*DTC are the only DC IGF participants in the GDC ongoing, both spoken and written submissions by **Omor** and **Pyrate**. We were also the only participant among all DCs at the Secretary General's Pact for the Future policy draft and also Declaration on Future Generations policy draft from **Omor** and **Dhruv**.*

- **Omor** spoke at the APriGF regarding “Online Safety: Balancing Children's Rights and Responsibilities”. He also attended a Fellowship Programme by bdIGF representing DTC. He was present during the UN Panel on Critical Energy Transition Minerals and highlighted the importance of utilising AI, Block-Chain & Technology.
- **Boris** spoke at the yIGF 2024 - APAC Youth Leaders Dialogue, and was a panel speaker at the Preface conference in Hong Kong.
- **Yuma** is working on an AI built website for DTC with **Pyrate**.
- **AJ** has written Blog posts and is connected to the Ghana IGF.
- **Catherine** is creating a community building plan for DTC Friends, and **Conan** and **Netra** are implementing it.
- **Sean** and **Catherine** spoke at a side event for Summit of the Future, Science Technology and Innovation Forum - Guide on Amplifying Tomorrow's Voices in Digital Governance, presented in collaboration with DTC and Global Initiative for Digital Rights. Audience of 20 people in a remote setting



- **Minna** leads DTC's efforts at WG Youth, and is our Lead in DC Organisational work, (Planning Liaison)
- **Boris, Pyrate** and **Catherine** worked on the DTC Friends Beta Discord that is still ongoing.
- **Pyrate** is working in DTC Development on the MOU signed with Learning Economy, and is also in Liaison with the DC Gaming for a Purpose.
- **Pyrate** became an Open Quantum Institute Friend at CERN and was personally invited to the 2024 Geneva Science and Diplomacy Anticipation Summit in October at CERN.
- **Pyrate** was an ongoing representative of Reset Tech to the AU Privacy Commissioner for Teens Rights to their own image and works in AI.
- **Dhruv** attended the Asia Pacific Regional Convening of Youth ahead of the Summit of the Future hosted by the Asian-Pacific Resource and Research Center for Women (ARROW) and other co-conveners (UNESCAP, CYMG, MGCY, and YECAP) that brought together around 80 youth from 21 countries across the Asia-Pacific to discuss the Summit of the Future and its crucial outcome documents: Pact for the Future, Declaration on Future Generations, and most importantly for us the Global Digital Compact.
