## **Dynamic Coalition Coordination Group (DCCG)**

## Virtual Meeting #73 | 6 June 2023

**Summary Report** 

## I. Adoption of the agenda

The agenda of the DCCG meeting #73 was adopted as proposed.

The call was moderated by the DCCG co-facilitator Markus Kummer. The list of participants is attached as Annex I.

## **II. Introduction of newly created Dynamic Coalitions**

## **Key points raised:**

- Three new official DCs were introduced, making it a total of 27 Dynamic Coalitions including the Youth Coalition:
  - <u>Dynamic Coalition on Blockchain Assurance and Standardization</u>
    Coordinators: Gerard Dache and Dino Cataldo Dell'Accio
  - <u>Dynamic Coalition on Open Educational Resources</u>
    Coordinator: Zeynep Varoglu (UNESCO)
  - <u>Dynamic Coalition on Data and Artificial Intelligence Governance</u>
    Coordinator: Luca Belli

#### III. Updates on IGF 2023 session proposals

#### **Key points raised:**

- There have been over 800 submissions this year (over half of which are workshop proposals). This is a record number of submissions received so far.
- The most popular workshop subthemes are (1) Digital Divides & Inclusion, (2) Artificial Intelligence & Emerging Technologies, and (3) Cybersecurity, Cybercrime & Online Safety
- A total of 30 DC sessions have been submitted. The proposals have been screened against the basic criteria of having published a DC annual report. Organizers have also been reminded that there can only be one DC session per coalition.
- Submissions for the IGF village is still open until 20 July 2023.
- DC session organizers were encouraged to have a diverse, gender-balanced panel, having at least two speakers and the moderator on site.
- DC session proposals can be edited at a later stage to correct typos and/or add speakers
- In order to attract more participants to DC sessions, it was suggested to highlight event titles before labelling events as *Dynamic Coalition* sessions, or to schedule all DC sessions in one slot to avoid high competition with workshops. The IGF Secretariat will look into how to best "rebrand" DC sessions to attract more participants.
- It was enquired whether a main session for DCs will take place this year. The IGF Secretariat will inform and/or remind the MAG in the upcoming MAG meeting in July.

#### **Next steps**

- > DCs will be further informed about their session submissions by end of July.
- > The main session for DCs at the annual IGF will be part of next meeting's agenda.

> The IGF Secretariat will prepare a main session proposal for DCCG's consideration (potential topics for the main session: successful IGF subthemes, niche topics, joint DC issues, inviting MAG members, following an interactive approach...)

## IV. Draft Charter of the DCs

## **Key points raised:**

- Changes were made to reflect last meeting's discussions
- It was suggested to provide a ist of active members who participate in DC group meetings to the Secretariat on demand, only, but not to publish it on the website.
- Once the Charter is approved, the MAG and LP will be informed to show how DCs improve their cooperation as part of the wider IGF ecosystem.
- It was suggested to include "other forms of collaboration" (ex: IG schools) to DC meetings.

#### **Next steps**

> The IGF Secretariat will share an updated clean version of the draft Charter to DCs.

#### V. Intersessional event: next steps

## **Key points raised:**

- The DC co-facilitator introduced the intersessional event concept at the virtual MAG meeting. The MAG provisionally approved the concept but would like to see how the session fits in the Open Consultation agenda and MAG meeting before making a final decision.
- The draft agenda has been sent to the MAG via email.
- There is a total of 62 registrations from members of the intersessional work.

#### **Next steps**

> The Secretariat will now reach out to participants who registered with further guidelines, also asking for their virtual or in-person participation.

## VI. Any other business

• Coordinators of two out three new DCs (DC-OER and DC-BAS) introduced themselves.
