Dynamic Coalition Coordination Group (DCCG)

Virtual Meeting #74 | 27 June 2023

Summary Report

I. Adoption of the agenda

The agenda of the DCCG meeting #74 was adopted as proposed.

The call was moderated by the DCCG co-facilitator Markus Kummer. The list of participants is attached as Annex I.

II. Draft Charter of the DCs

Key points raised:

- The Secretariat shared a PDF version of the draft agenda prior to the meeting and introduced all changes implemented in the document.
- It was suggested to bring the Charter forward to the MAG via email and during its upcoming meeting in Geneva.

Next steps

- **Any final comments should be addressed to the IGF Secretariat by the end of the week. If no comments are provided, the draft Charter is approved by tacit agreement and can be published on the IGF website.**

III. Intersessional event: update & feedback

Key points raised:

- The Secretariat provided an update of the kick-off meeting as well as of the individual working group meetings to prepare the intersessional event.
- It was suggested to include a column in the intersessional event registration sheet outlining the intersessional work category the participants belong to in order to show the diversity of participants in the various working group.
- The Secretariat informed about the less popular working groups, and DC coordinators suggested to reach out to their DCs to ask again for potential interested participants for those specific working groups.
- The intersessional event schedule will adapt its rundown depending on how active the various working groups will be in the upcoming two weeks.
- It was mentioned that the MAG was confused about the intersessional event and that it would be beneficial to inform the MAG again about the concept of the event.

Next steps

- **The Secretariat will add a column in the registration sheet of the intersessional event to show what intersessional work activities participants belong to.**
- **The intersessional event will be properly introduced to the MAG.**
- **DC coordinators to reach out to their DCs to enquire about interested participants in the less popular intersessional event working groups.**

IV. Open Consultations and MAG meeting: draft agenda

Key points raised:

- The Draft Open Consultations and MAG meeting agenda has been published on the IGF website and shared with the DCCG members.

V. IGF 2023 DC main session proposal**Key points raised:**

- It was suggested to present a draft concept note to the MAG in order to secure a DC main session slot at the annual IGF.
- The Secretariat reminded DCCG members that the IGF received a record amount of session proposals and due to the space constraints of the venue, slots will have to be attributed to sessions more competitively this year.
- In order to present a strong DC main session proposal and avoid duplications, it was suggested not to opt for a topic of another high-level or IGF main session. As the MAG is planning to prepare a main session about upcoming digital governance processes such as the GDC, the DC main session should focus on a different theme, even though a DC main session could present similar topics through a different angle.
- It was agreed to start a concept note around this year's IGF theme "The Internet We Want", as this is a topic every DC can contribute to.

Next steps

- **The Secretariat will prepare a short, draft concept note for the DC to elaborate.**
- **The draft concept note can be presented to the MAG for their DC main session slot approval.**

VI. Any other business

- It was suggested to arrange a meeting between the MAG and DCs or the entire intersessional work community at the annual IGF 2023.
- The next DCCG meeting #75 will be scheduled in the week after the MAG meeting.

Next steps

- **The IGF Secretariat took note of the meeting request.**
- **The IGF Secretariat will send out a Doodle poll to schedule the next DCCG meeting #75.**
