### Dynamic Coalition Coordination Group (DCCG)

#### Virtual Meeting #75 | 20 July 2023

##### Summary Report

### **I. Adoption of the agenda**

The agenda of the DCCG meeting #75 was adopted as proposed.

The call was moderated by the DCCG co-facilitator Markus Kummer. The list of participants is attached as Annex I.

### **II. Brief of the Open Consultations (OC) and MAG meeting**

#### **Key points raised:**

- Participants were informed that the MAG agreed on the final list of workshop submissions and discussed 5 preliminary main sessions. Topics on Gender and Human Rights & Freedoms are still pending and could either be treated as cross-cutting or as separate main sessions.
- Participants were also informed about the Leadership Panel (LP) meeting that was held right after the OC & MAG meeting. Meeting notes will soon be made official and will be shared via the DC mailing list for further information.
- The feedback around the intersessional event was shared. While some participants and MAG members who took part in the event shared their interest in the session, some also mentioned that they have not been properly made aware of the purpose of the event.
- MAG members and participants in the OC appreciated being informed about the whole range of intersessional activities by DCs NRIs BPFs and PNs in this format.
- While it was suggested to hold the intersessional event more regularly, such as at the main IGF, participants were reminded that it remains at the discretion of the MAG to approve it.
- It was suggested to hold a meeting between DCs/intersessional work community and the MAG at the IGF in Kyoto, to discuss how intersessional work can better be integrated in the overall IGF programme/outputs.

#### **Next steps**

- **The IGF Secretariat will share the OC & MAG meeting notes, which include the summary document of the intersessional event and working group presentations, as soon as the MAG Chair reviewed meeting notes. The summary of the Leadership Panel meeting will also be shared with DCs.**
- **The IGF Secretariat will propose and facilitate a stand-alone meeting with the MAG during the IGF in Kyoto.**

### **III. DC Main Session Proposal and Way Forward**

#### **Key points raised:**

- It was noted that there has first been some pushback from few MAG members regarding the organization of a DC main session. It was later explained that a DC main session has been organized at the annual IGF for the past couple of years and that DCs will ensure to organize a forward-looking session during which the coalitions show how they contribute to the *Internet We Want*.

- Participants were informed that the LP is working on a substantive document that outlines their view on the *Internet We Want*. Below are five (draft) subgroups that can be built upon:
  - Whole and open
  - Universal and inclusive
  - Free-flowing and trustworthy
  - Safe and secure
  - Rights respecting
- While different topics under the overarching theme of *The Internet We Want* were suggested in the call, there was agreement that the sub-theme of *The Internet We Want* should be related to the nexus between human rights and SDGs (e.g., a human rights perspective to achieve the SDGs). The session should be clustered in accordance with the 5 (draft) subgroups developed by the LP with the main heading “*The Internet We Want*” and sub-heading “*Human Rights in the digital space to accelerate the SDGs*”
- It was recommended to use a template (similar to the one used for the organization of the DC main session on SDGs in 2018) to facilitate the preparation of the DC main session amongst the 26 DCs.
- The DCs participating in the DC main session will be requested to send a one-pager by 10 August 2023 on how their DC contributes to the five subgroups of *The Internet We Want*.
- The DC main session should be fully organized by mid-September, latest (confirmed speakers onsite/online, moderators, presentations etc.)

#### Next steps

- **The IGF Secretariat together with DC volunteers will develop a template/mini-survey to facilitate preparations of the DC main session.**
- **DCs that wish to take part in the DC main session will be requested to submit to the IGF Secretariat a one-pager by 10 August 2023 on how their DC contributes to the five subgroups of *The Internet We Want*.**
