

## IGF 2024

### Dynamic Coalition Coordination Group (DCCG)

#### Virtual Meeting #82 | 21 February 2024

#### Summary Report

#### **I. Adoption of the agenda**

The agenda of the DCCG meeting #82 was adopted as proposed.

The call was moderated by the DCCG co-facilitator Markus Kummer. The list of participants is attached as Annex I.

#### **II. Updates from the Secretariat**

##### **Key points raised:**

- Participants were reminded that the [First Open Consultations and MAG Meeting](#) is taking place next week from 27 to 29 February 2024 in Riyadh, Saudi Arabia. The [draft agenda](#) has been published on the IGF website. For those who did not register for online participation can join via the Zoom link that will be published on the [event webpage](#).

#### **III. DC's Integration into the IGF 2024 Programme**

##### **Key points raised:**

- The co-facilitator referred to the [meeting notes](#) from the DCCG Meeting #81, which summarized discussions around the potential integration of DCs in the IGF 2024 programme.
- A survey was sent to DCs via a [Microsoft Form](#) to identify the various DC needs in terms of programme integration. The most selected option is to organize joint DC sessions amongst thematically similar DCs, followed by Day-0 events and by bilateral meeting rooms to organize DC annual meetings. Providing several ways to participate in the IGF will most probably lower the need to organize individual DC sessions. The Secretariat will send a reminder to DCs to take part in the survey, as there have been only 9 respondents so far.
- The MAG will meet in-person and online next week to agree on the IGF 2024 programme structure. The DC co-facilitator will provide a summary of suggestions (including a preamble) on how to preferably integrate Dynamic Coalitions in the IGF 2024 programme.

DCs recognize the practicalities of the IGF programme organization, considering the growing number of DCs. As a positive effort to meet that challenge and strengthen the IGF, DCs suggest the following:

- (1) DCs are interested to maintain a DC main session, similar to the NRIs, PNs and BPFs. The DC main session could take a different form this year, based on the DCCG stock taking from the IGF 2023.
- (2) There should be an agreed number of DC sessions run collectively by DC groups. There could be a selection process run by a jury of DC members who did not submit a DC session proposal.
- (3) Those Dynamic Coalitions that do not need DC sessions can be allocated in a bilateral meeting room to hold their IGF annual meetings, as an opportunity to have an in-person meeting point at the IGF. These bilateral room meeting allocations would then not be part of official programme.

- (4) The Dynamic Coalitions would also organize a joint DC IGF village booth.
  - (5) The DCs will be encouraged to join thematic discussions related to main sessions or any other IGF session.
  - (6) The DCs expressed their interest in organizing another intersessional event sometime in the year, showcasing the tangible output of some DCs ahead of the IGF 2024.
- DCs were also encouraged to participate in the consultations of the [Internet We Want](#) paper (deadline 1 March) to integrate DC perspectives and expertise that may be missing in the document.

#### Next steps

- DCs who did not take part in the [Microsoft Forms survey](#) on the integration of DCs in the IGF 2024 Programme should do so as soon as possible.
- DCs who are interested in contributing to the Internet We Want consultations can provide comments [here](#) by 1 March.

#### **IV. DCCG's input to the CSTD questionnaire**

##### Key points raised:

- The DCCG provided input to the MAG responses of the [CSTD questionnaire](#) for questions 7, 9, 10, 11, 12. The facilitator of the MAG working group on strategy, leading the process, has been informed and intends to submit a final response by the end of the week.
- The link to the list of Dynamic Coalitions has been included in the MAG response.

#### **VI. Any other business**

##### Key points raised:

- The MAG WG on Youth Engagement has been launched and DC members have been encouraged to join the dedicated [MAG WG-Youth mailing list](#). The Youth Coalition on Internet Governance plans on actively participating in this WG.
- The Secretariat will draft a specifier to clearly indicate the role that DCs have within the IGF.
- While DC outputs are not UN outputs, DCs could bring up the issue to the MAG of recognizing them as IGF outputs.
