Dynamic Coalition Coordination Group (DCCG)

Virtual Meeting #85 | 12 June 2024

Summary Report

I. Adoption of the agenda

The agenda of the DCCG meeting #85 was adopted as proposed and is available in Annex I. The call was moderated by the DCCG co-facilitator Markus Kummer. The list of participants is attached as Annex II.

II. Updates from the Secretariat

Key points raised:

- The IGF Secretariat organized two events at the WSIS Forum High-Level event, which took place on 28 May and 30 May in Geneva on “[Advancing the GDC Principles and WSIS Action Lines](#)”, as well as on the “[Journey to ‘Building Our Multistakeholder Digital Future’](#)”. These events were very well attended. The IGF booth has also had a high traffic, including different crowds, namely participants from the WSIS Forum High-Level Event, as well as from the AI Summit for Good.
- Regarding the Intersessional work:
 - The Policy Network on Meaningful Access (PNMA) held its first meeting on 11 June. Recordings are available [here](#) and their next meeting will take place end of July (date to be confirmed).
 - The first meeting of the Policy Network on Internet Fragmentation (PNIF) will be held on 19 June 2024, from 14:00 to 15:30 UTC. Interested DCs can [register here](#).
 - The first meeting of the Best Practice Forum on Cybersecurity will be held on 20 June from 13:00 to 14:00 UTC. Interested DCs can [register here](#).
 - The next Policy Network on Artificial Intelligence (PNAI) Multistakeholder Working Group meeting will take place on 21 June 2024 from 11:00 to 12:00 UTC. Interested DCs can register for the meeting [on PNAI Materials page](#).
- The workshop evaluation will enter a new phase as of 14 June, as from Multistakeholder Advisory Group (MAG) members will proceed with group evaluations. The suggested list of selected proposals will be presented and discussed at the Second Open Consultations and MAG meeting.
- The IGF Secretariat is currently finalizing the initial screening of all IGF session proposals and will soon publish all the proposals *received* on the website.
- Currently, there are over 400 registrations for the [Second Open Consultations and MAG Meeting](#) taking place from 26 to 28 June 2024 in Geneva, Switzerland, with the Open Consultations day scheduled on 26 June. The [registration platform](#) is still open.

Next steps

- **Interested DCs to register for upcoming PNIF and PNAI meetings.**
- **The IGF Secretariat to publish all *received* IGF session proposals on the IGF website.**

III. Intersessional Event at the 2nd Open Consultations and MAG meeting

Key points raised:

- As the MAG did not have any comments regarding the [draft agenda](#) of the 2nd OC and MAG meeting, the [concept note for the Intersessional Event](#), which will take place from 15:00 to 16:30 (CEST) on 26 June, has been shared via email with all DC members.
- DCs, as well as Policy Networks (PNs) and Best Practice Forums (BPFs) will be asked to respond to a survey that will be sent by the Secretariat, and to contribute to an IGF 2024 subtheme.
- Before giving the floor to representatives of IGF intersessional work to present findings under each IGF 2024 subtheme, the Secretariat will introduce the IGF intersessional work, such as community reach and some spotlighted topics. The percentage of IGF 2024 session submitters who are affiliated to intersessional work will also be mentioned.
- It will only make sense to plan a DC main session after the 2nd Open Consultation and MAG meeting, as the MAG will start identifying topics of their main sessions at the meeting.
- Some initial DC main session topics were shared by DC members, such as what DCs could contribute to the future of the IGF or connecting the topics to one of the IGF 2024 sub-themes.

Next steps

- **The IGF Secretariat to send a survey to all DCs, NRIs and BPF/PNs and gain insights for a Secretariat presentation of IGF intersessional work to the MAG.**
- **The structure and session down of the intersessional event will be shared with DCs.**

IV. Joint Dynamic Coalition Booth proposal

Key points raised:

- A IGF 2024 Joint DC booth proposal has been prepared in this [Google Document](#). The IGF Secretariat has **kindly ask each DC to indicate their interest in participating in such a Joint DC booth**, as well as to indicate on-site presence in Riyadh (to staff the booth throughout the week of the IGF by alternating amongst DCs).
- The IGF Secretariat submitted a proposal prior to the deadline of 30 June.
- At a previous IGF, DCs had a joint booth which was not well staffed. It will be important to have onsite DC members commit to staff the booth. The IGF Secretariat will coordinate attendance well in advance.

Next steps

- **The IGF Secretariat will prepare a DC brochure and will prepare a time table for DC members to staff the booth.**

Key points raised:

- The IGF Secretariat will send out a Doodle Poll to schedule the next DCCG meeting in July, after the 2nd Open Consultations and MAG meeting ended.
