# **Dynamic Coalition Coordination Group (DCCG)**

## Virtual Meeting #89 | 7 October 2024

## Summary Report

The participants of the Dynamic Coalition Coordination Group (DCCG) Meeting #89 discussed the proposed draft agenda for the IGF 24 in December, with a focus on the concept paper for the IGF 24 DC Main Session and the formation of a core team to shape the session description and speakers list. They also discussed the creation of a brochure for the DCs booth at the upcoming event, the potential interconnections between dynamic coalitions and the IGF ecosystem, as well as the management and organization of DCs within the IGF. Concerns were raised about time constraints for preparing sessions and the need for better organization of the coalitions, with a suggestion for a research project to understand the Dynamic Coalitions better based on the earlier conducted research.

## I. Adoption of the draft agenda

The agenda of the DCCG meeting #89 was adopted as proposed and is available in Annex I. The call was co-moderated by the DCCG co-facilitators Jutta Croll and Markus Kummer. The list of participants is attached as Annex II.

## II. IGF 2024 DC Main Session

The co-moderator proposed the formation of a core team to shape the <u>DC Main Session at the IGF</u> description. DC members agreed to provide their suggestions by the next morning. The co-moderator also suggested including several members of the DCs in the core team, as well as those who will indicate their interest, with the condition that they should not be speakers at the main session. The team would potentially include Rajendra, Judith, Jutta, Joao, and Roman on behalf of the IGF Secretariat and to meet next week.

# III. Joint DC IGF Village Booth and DC brochure

The DCCG discussed the creation of a brochure for the Dynamic Coalition (DC) booth at the upcoming event. The brochure, to be prepared by the IGF Secretariat, would provide a concise overview of DC's work and activities, with QR codes for easy access to their documents and activities. The team agreed to keep the brochure short and attractive, with the aim of attracting new members and encouraging the creation of new DCs. Suggestions and inputs were encouraged from the team members, including adding a feature to join the DC directly from the brochure, which was appreciated.

#### IV. Meeting with the MAG at the IGF 2024

The group also discussed the upcoming meeting with the MAG, with IGF Secretariat proposing it be held on IGF Day 0. Participants suggested that involving MAG members in the work of the DCs could create more synergies and increase visibility. It was agreed, recalling positive feedback from previous information sessions about the DCs' work.

# V. Any other business

The DCCG discussed the management and organization of dynamic coalitions within the IGF. There were raised concerns about the overwhelming number of coalitions, suggesting a need for better organization and possibly sub-themes to make navigation easier. IGF Secretariat proposed monthly thematic cluster webinars to raise awareness and promote the work of the coalitions. The co-

moderator agreed with the need for better organization and the importance of keeping the option for new coalitions open. The meeting participants agreed on the need for a strategy to balance the need for organization with the importance of keeping the option for new coalitions open.

## Next Steps

- DCs Co-facilitator to coordinate on preparing the DC Main Session for IGF 24 together with others Core Group volunteers.
- IGF Secretariat to schedule a DC Coordination Group Meeting on the IGF Day 0 to prepare for the meeting with the MAG.
- IGF Secretariat to schedule a joint DC Coordination Group and MAG meeting to discuss better integration of DCs in the IGF ecosystem.
- IGF Secretariat to share the previous research paper on DCs with the group for reference and potential update.
- DCs to indicate their availability to staff the joint DC booth throughout the week of the IGF, with a particular focus on lunch hours.
- DCs to provide any documents they want to display at the joint DC booth to the IGF Secretariat by the end of October.
- IGF Secretariat to prepare a draft brochure for the DC booth at IGF 24, including a categorized list of DCs and potentially scheduled events for the next year.
- DC members to provide input on the draft brochure by mid-November.
