Dynamic Coalition Coordination Group (DCCG)

Virtual Meeting #91 | 25 November 2024

Summary Report

The participants of the Dynamic Coalition Coordination Group (DCCG) Meeting #91 focused on the IGF 2024 DC Main Session and core team's efforts for preparation of content and speakers with responsibilities and deadlines set. They also discussed the creation of a brochure for the DCs booth at the upcoming event. Visa process and possible related difficulties were also discussed during the meeting. The conversation ended with discussions on the progress of the Global Digital Compact.

I. Adoption of the draft agenda

The agenda of the DCCG meeting #90 was adopted as proposed and is available in Annex I. The call was co-moderated by the DCCG co-facilitators Jutta Croll and Markus Kummer. The list of participants is attached as Annex II.

II. IGF 2024 DC Main Session

The co-moderator shared the results of the core team's efforts to shape the [DC Main Session at the IGF](#) focused on the Global Digital Compact and the contributions of the dynamic coalitions to its five main objectives. The session was set to include a panel discussion, floor interventions, and a wrap-up. The team discussed the structure and content of the main session for the upcoming event. They agreed on the need for a structured approach to presentations, with guidelines but also some flexibility for the speakers. The speakers were to refer to the DCs they represent and their contributions to the main objectives. They also discussed the importance of mentioning the outcomes of the DCs' work, not just listing their reports. They also considered displaying a list of links to the reports on the screen. Co-moderator also mentioned that they were still waiting for representatives from all the dynamic coalitions to sign up for the session. There was a consensus on having speakers on site, but the possibility of online speakers was also discussed. The meeting focused on the progress of the Global Digital Compact, with discussions on the input received from various groups and the need for more contributions. The team agreed to set a deadline for those who haven't provided input, with the possibility of excluding them from the session if they don't respond. The participants also discussed the representation of the DCs, with some not having provided input or reacted to invitations. The team decided to give a 48-hour deadline for further input and to prepare for the session. The meeting also touched on the need for gender balance in the speakers and the representation of the DCs at the IGF.

III. Meeting with the MAG at the IGF 2024

The team discussed the upcoming meeting with the MAG on the IGF Day 4. Co-moderators proposed an agenda that included combining the presentation of the DC Main session and the role of the DCs in the GDC implementation due to their overlap. Participants proposed giving a summary of the results of the session by the rapporteurs or moderators. The team agreed that the meeting with the MAG would be an opportunity to focus on the work done before moving further. There was a discussion on the potential changes in the relationship with the MAG due to UN expectations, emphasizing the need for understanding and communication. Co-moderator suggested that the DCs need to define their role and not wait for instructions. The need for feedback on how the DCs can fulfill their role, as well as the importance of focusing on the next IGF due to the short planning period were also discussed.

IV. Joint DC IGF Village Booth and DC brochure

The DCCG discussed the creation of a brochure for the Dynamic Coalition (DC) booth at the upcoming event. The brochure, to be prepared by the IGF Secretariat, would provide a concise overview of DC's work and activities, with QR codes for easy access to their documents and activities. There will be also a document created by the IGF Secretariat to allocate slots among the DCs to volunteer at the booth and a chat for on-site DCs focal points to coordinate their activities.

V. Any other business

The meeting discussed the progress and organization of the Internet Governance Forum, particularly the DCs' work. There was a suggestion of a more collaborative approach among the DCs, as well as the need for further planning for the village booth and the DC brochure. The dates for the 20th IGF in Norway were announced with concerns about the compressed timeline for the next IGF preparation.

Next Steps

- DC representatives to provide input for the main session within 48 hours (by Wednesday, 27 November).
- IGF Secretariat to finalize the DC brochure design and content.
- DCs to prepare slideshows for display at the IGF village booth.
- Co-facilitators to present the DC main session concept and proposed agenda for the MAG meeting at tomorrow's MAG meeting.
- Speakers for the DC main session to prepare 7-minute presentations addressing their respective GDC objectives and including thought-provoking questions.
