### Dynamic Coalition Coordination Group (DCCG)

#### Virtual Meeting #96 | 18 March 2025

##### Summary Report

The meeting discussed the preparation of the first DC webinar. They also discussed the ongoing issue of gathering data on participation and location of members in DCCG meetings, the need for improving inclusivity and accessibility in the community's communication platforms, and preparations for the upcoming IGF 2025. Lastly, they discussed scheduling a meeting, the gamification platform, a working group strategy, and the next call.

#### **I. Adoption of the draft agenda**

The agenda of the DCCG meeting #96 was adopted as proposed and is available in Annex I. The call was co-moderated by the DCCG co-facilitators Jutta Croll and Markus Kummer. The list of participants is attached as Annex II.

#### **II. Preparation of the first DC Webinar in March**

The group discussed the preparation of the first DC webinar with Rajendra Gupta as its main moderator and coordinator. The topic for the first webinar was decided as "Global AI Governance for Humanity's Benefit". The meeting discussed the topics for the next webinars, with suggestions that the DCs should decide in which clusters and topics they fit the most: under AI governance or one of the other three themes. It was also suggested to involve the IGF Policy Network on AI to participate in the webinar. Some concerns were expressed about the length of the upcoming webinar, suggesting it should not exceed 1 hour. It was also suggested that the session's success could be measured by the number of attendees who stay on until the end. The group agreed to postpone the upcoming webinar from March 27th to April 3rd at 15:00 UTC to allow more time for preparation and promotion. The team discussed time zone considerations to ensure maximum global participation.

#### **III. Preparation for the DC sessions in groups**

The meeting discussed organizing their participation in the upcoming IGF. They plan to organise an onsite booth, which was successful in the previous year's IGF. DCs aim to have four collaborative sessions in workshop rooms, prepared through webinars, as well as a concluding main session. The deadline for submitting proposals for these sessions is the end of April. There is a suggestion to link the themes of the workshops and main session to showcase the intersessional work of the DCs throughout the year. The meeting acknowledged the urgency to start planning the themes and content for these sessions.

#### **IV. DCs accountability**

The meeting discussed the ongoing issue of gathering data on participation and location of members in the DCCG meetings. The importance of fostering participation from all groups, especially weaker ones, was emphasised. Participants raised the issue of multitasking platforms like Slack, where active participation from DC members can increase productivity. The co-facilitator recalled that a DC document from 2021 had raised similar issues, and it was agreed to revisit it. The meeting focused on improving inclusivity and accessibility in the community's communication platforms. It was also highlighted that using the mailing list for asynchronous communication and rotating meeting times are already in place. The importance of accessibility for people with disabilities was emphasized.

along with using Google Docs for asynchronous discussions. The meeting agreed to continue discussing these issues and exploring new platforms.

#### **V. AOB**

The team discussed scheduling a next meeting for the 11th April. Reyansh updated on the gamification platform, aiming to send an email by the next meeting and have the leaderboard ready. Wout presented progress of the MAG Working Group on IGF Strategy, outlining six topics and assigning responsibilities.

#### **Next Steps**

1. IGF Secretariat to send out the raw transcript of the meeting to the DC list immediately after receiving it from Caption First.
2. Rajendra, Jutta, Judith, Dino, and Avri to form the core team for preparing the main session and 4 thematic sessions.
3. Avri to create 4 Google Drive documents for the core team to start working on session ideas.
4. Core team to meet to discuss progress on main session and thematic sessions preparation.
6. DCCG to meet on April 11th at 12:00 UTC.
7. Reyansh to send an email explaining how the gamification platform will work.
8. Reyansh to have the gamification leaderboard up by next call.
9. Wout, Avri, Anriette, and Amrit to continue working on the 6 topics identified by WG Strategy.
10. DC members to provide input on the 6 Working Group Strategy themes when requested by the subgroup leads.
