Please describe the Discussions that took place during the workshop session: (3 paragraphs)	Discussion began with positives of internet and social media as an alternative space for assembling online, forming associations and campaigns. Speakers from Pakistan and India discussed significant case studies from their countries and then the discussion moved forward on actual challenges when mobilizing support online for campaigns or joining associations for common goals.
	During discussion, one of the common challenges emerged as network shutdowns in countries to restrict people from social media campaigns or disconnecting them from communications and accessing information. India and Pakistan highlighted the reasons of network shutdowns and also discussed socio-economic aspects. Speaker from Access Now also contributed towards the socio-economic aspects and also brought the perspective on network shutdowns from other countries including Gambia, Bahrain, etc. Speaker from Malaysia presented Bersih 5 rally and specifically talked about challenges faced by the organizers.

Quite a significant number of questions were posed to Facebook speaker during the discussions regarding its role towards rights to freedom of association and of assembly and how it responds to the challenges highlighted by other participants. Facebook representative presented its company's standpoint on abuse of their platform, issue of disinformation, and others. Facebook also encouraged the civil society and other stakeholders to approach them in matters of urgent need and bringing into consideration the serious rights violations, abuse or violation of community rules. One of the participants suggested that tools from the intermediary
companies should be given to social media users so that they can decide how to counter threats to online assemblies and associations
instead of blocking and censoring content on arbitrary basis.
