Recap of the 1st webinar

- > overlap, duplication and gaps in cybersecurity capacity building = inefficient use limited resources
- > no need for another BPF mapping of cybersecurity capacity building initiatives
- > many valuable initiatives already map cybersecurity capacity building efforts, for example Cybil portal by GFCE, UNIDIR cyberportal, Global Cyber Security Capacity Centre, and many more, but there is no good overview of who is doing what, where, and with what focus and purpose
- > important to provide an overview and avoid overlap and duplication at the level of these mapping efforts and databases that aim to make information on cybersecurity capacity building available to others
- > potential gains of cooperation and exchange change of information between such initiatives

Mainstreaming capacity building for cybersecurity, trust, and safety online

Draft outline & methodology BPF

1. define the issue of overlap in cybersecurity capacity building, the consequences and missed opportunities
2. compile an overview of existing mappings and inventories of cybersecurity capacity building efforts, and categorise by focus & topics, target users, etc.
3. collect case studies of cooperation and coordination between mappings and inventories of cybersecurity capacity building, to draw lessons on perceived benefits, obstacles, etc..
4. prepare draft conclusions and recommendations for discussion at the BPF session at IGF 2024
