INTERNET GOVERNANCE FORUM (IGF)

What is the IGF?

- World Summit on the Information Society (WSIS), two phase:
- Phase I, 2003: stakeholder requested the United Nations Secretary-General to establish a multi-stakeholder Working Group on Internet Governance (WGIG)
- Phase II, 2005: Paragraph 72 of the Tunis Agenda called on the UN Secretary-General to convene the IGF
- The convening of the IGF announced on 18 July 2006. Inaugural meeting held in Athens, Greece, from 30 October to 2 November 2006.

IGF Mandate

- 2006 – 2011 -2015
- **16 December 2016, United Nations General Assembly extended the IGF mandate for the next 10 years**

Organizational Structure

IGF MAG

- The Secretary-General of the United Nations established the Advisory Group (now referred to as the Multistakeholder Advisory Group - MAG). Its purpose is to advise the Secretary-General on the programme and schedule of the Internet Governance Forum meetings. The MAG is comprised of 55 Members from governments, the private sector and civil society, including representatives from the academic and technical communities.

Organizational Structure

IGF SECRETARIAT

- Based at the United Nations Office in Geneva
- Coordinates the IGF processes

- **Open Consultations and MAG face to face meetings**
- **Community Intersessional work**
- **Annual Meeting**


Open Consultations and MAG face to face meetings

- 2 – 3 meetings during a year with many of virtual meetings in between


Community Intersessional work
