### ***Focus and general plan of the session:***

There will be a presentation of 4 oral dissertations between 15 and 17 minutes each. The dissertations are expected to show the different dimensions of innovation for governance and cooperation between countries of the southern hemisphere.

In each of the sessions, questions from the public and voting on dimensions previously established by the panelists will be received.

At the end of the 80 minutes, the 4 panelists will answer the most interesting questions they received through virtual means, 3 minutes each.

At the end of the presentations, the moderators will make closing interventions of 5 minutes each, exposing the results of the votes made by attendees and their relationship with the materials exposed by the panelists.

Meanwhile, the rapporteur will be in charge of compiling the main aspects of each response and the main questions asked to record them in a microsite open to the public.

### **How will you facilitate interaction between in-person and online speakers and attendees?**

In each session, the panelists will ask questions open to the public and votes that will be made by the attendees. These can be accessed by scanning QR codes.

In the halftime between each presentation, the panelists will select and answer the most relevant questions from the attendees. In the question answering session at the end of the presentations, each panelist will have 3 minutes to present the main answers.





At the end of the session, a QR code will be provided to the attendees so that they can access the results of the rapporteurship online. Allowing them to review the questions asked, the results of the voting and the recordings of the interventions of the panelists.
